



## **Charge Account Application Form**

### **SECTION 1 - TERMS AND CONDITIONS.**

1. The undersigned accepts full accountability and agrees to pay 8800 Taxi Inc. all amounts owing in respect of taxi fares and any other charges under this credit agreement.
2. Charge accounts may be terminated at any time by 8800 Taxi Inc and all charges shall become payable immediately, in addition to any charges which may occur out of essential costs to recover any outstanding balances.
3. 8800 Taxi may amend any term or condition of the credit agreement by giving the charge client 30 days written notice. No alteration or amendment by the charge client may alleviate them from any obligation under this agreement.
4. Any disagreement related to the statement or invoice of account will be brought to the attention of 8800 Taxi within 14 days of the invoice or statement date, or else it will be considered correct.
5. Charge client must advise 8800 Taxi within 6 days of a change of name or address to the charge account.
6. All charge accounts are due and payable upon receipt and accounts are billed by the 5<sup>th</sup> day of each month.
7. A 5% administration fee will be applied to each invoice with a minimum charge of \$5.45; G.S.T is included on all rates and administration fees.
8. Administration fees will not apply for accounts without any activity within a monthly billing period.
9. Any charge account balances outstanding or unpaid by the end of the month will be subject to a 2% interest charge per month.
10. To close an account, 8800 Taxi must be informed in writing.
11. Any items or cheques returned will be subject to a \$20 service charge for each item returned.
12. Charge account slips will be supplied, filled out and signed by the driver. The passenger also signs and receives a copy of the charge slip.
13. A credit check on the applicant may be referred to in relation with the credit hereby applied for.
14. Authorization and approval to activate any charge account agreements with 8800 Taxi Inc. may take up to 3 or 4 days.
