

UNCONDITIONAL AND FULL GENERAL RELEASE, WAIVER, INDEMNITY AND MEMBERSHIP AGREEMENT

In consideration of Jacksonville Jaguars, LLC (the "*Jaguars*") allowing me, the undersigned, to be a member of, receive the membership benefits associated with, and participate in events hosted or sanctioned by the Jaguars women's club (including, without limitation, football clinics, education sessions, and social events) (collectively, the "*Membership Benefits*"), I hereby represent, warrant and agree as follows:

1. **Age:** I am at least 18 years of age or older.
2. **Membership Dues:** I agree to pay my membership dues as and when due.
3. **Membership Benefits:** I agree to comply with the rules regarding the Membership Benefits established by the Jaguars and/or its designees from time to time. I acknowledge and agree that the Jaguars may establish the Membership Benefits given to members in its sole discretion.
4. **Assumption of Risk:** I hereby freely and expressly assume all the known and unknown risks inherent in the Membership Benefits (including, without limitation, death, broken or fractured body parts and injuries from other members of the Jaguars' women's club). I acknowledge that certain of the Membership Benefits may include events that involve physical challenges and exertion and/or may carry the potential for death, serious physical injury and property loss.
5. **Waiver and Release:** I hereby release, covenant not to sue and forever discharge the Jaguars, its sponsors, the operator and/or manager of the stadium at which the Jaguars play, any vendor providing any services or goods as part of the Membership Benefits, and their respective directors, officers, owners, members, managers, partners, representatives, agents, employees and affiliates (collectively, the "*Releasees*") of and from any and all claims, demands, suits (including in equity), causes of action, judgments, losses, liabilities, damages, costs and expenses of any nature, whether caused by, arising out of or based on the active or passive negligence of any Releasee or otherwise, arising out of or in any way connected with the Membership Benefits, including any traveling in connection with the Membership Benefits, including, without limitation, any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and/or death) (collectively, the "*Claims*").
6. **Indemnification:** I hereby agree to indemnify, defend and hold harmless the Releasees and their respective heirs, successors and assigns from and against any and all such Claims, including, without limitation, attorneys' and other professionals' fees and costs. I understand that the foregoing release and this indemnity includes, without limitation, any Claims based on the negligence, action or inaction of any Releasee (including in procuring medical treatment on my behalf) and covers personal and bodily injury (including death) and property damage.
7. **Grant of Rights:** I irrevocably grant permission to Releasees (i) to photograph, take motion pictures of, or televise, and reproduce in any manner or through any media my image and voice; and (ii) to use, display, license or sell my name, likeness, voice, biographical data, appearance or image in motion pictures, telecasts, publications, distributions or reproductions or any other media now known or hereafter developed (including, without limitation, over the internet, in newsletters and e-mail blasts), in each case, for any purpose (commercial or otherwise), without reservation or limitation and without compensation.
8. **Governing Law:** This general release and agreement shall be governed by and construed in accordance with the laws of the State of Florida. The state and federal courts of Duval County, Florida, shall have exclusive jurisdiction over any dispute arising out of or based on this general release and agreement.
9. **Separability:** If any provision of this general release and agreement, or the application thereof to any person or circumstance, shall to any extent be held invalid or unenforceable in any jurisdiction, (i) the remainder of this general release and agreement shall not be affected thereby and shall be valid and enforceable to the fullest extent permitted by law, and (ii) the court making such determination shall have the power to reduce the scope or applicability of such provision (including by deleting or replacing specific words and phrases) in a manner that makes such provision valid and enforceable and comes closest to expressing the intention of the invalid and unenforceable provision.

I HAVE CAREFULLY READ THE ABOVE AGREEMENT (INCLUDING THE GENERAL RELEASE AND INDEMNITY) IN ITS ENTIRETY AND FULLY UNDERSTAND ITS CONTENTS. I UNDERSTAND THAT I AM ASSUMING ALL RISKS INHERENT IN THE MEMBERSHIP BENEFITS AND THAT I AM GIVING UP MY RIGHT TO RECOVER FROM THE RELEASEES IN A LAWSUIT. I UNDERSTAND THAT I HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM AND THE JAGUARS HAS THE RIGHT TO REFUSE TO LET ME PARTICIPATE IN THE WOMEN'S CLUB. I HAVE SIGNED THIS DOCUMENT VOLUNTARILY AND OF MY OWN FREE WILL.
