Eligibility Conditions for the teachers to attend the course

- The eligibility for attending the Refresher Course for teachers who have not attended earlier orientation course has been reduced to "two years" from "five years". However, the gap in two successive Refresher Courses should normally be "one year" and may be relaxed on the discretion of the course organizers or it is essential for the teacher to fulfill eligibility conditions for his career advancement.
- Lecturers working in Universities and Colleges, who are included in the list of colleges under section 2(f) of the UGC Act, even though may not yet to be fit under 12-B of the UGC Act, may be invited to participate in the Refresher Courses. It has been agreed that the teachers of Colleges which do not yet come within the purview of Sec. 2 (f), but have been affiliated to a University for at least 5 years be permitted, to participate in the Refresher Courses.
- The temporary / contract teachers, who have been teaching for at least two
 academic sessions in an institution which has been affiliated to a University for at
 least two years may be allowed to participate in the Refresher Course to
 enhance their skills.
