The above mentioned remaining amount will become payable by no later than the 7th (seventh of each following month).

**\* IMPORTANT: By Law, consumers are only allowed to sign two PAYMENT AGREEMENTS per annum (per year).**

I agree that in the event of failure to comply with the payment conditions of this agreement, that Global International Meter Services CC may:

- a. disconnect the electricity and/or block my prepaid meter without any further notices served should no proof of payment be send by me on or before the agreed deposit downpayment date stipulated above and;
- b. in terms of section 57 of the Magistrates Court Act, 1944 ( Act 32 of 1944 ) apply for judgement order of court for payment of the judgement debt and cost of instalments or otherwise in accordance with this agreement.
- c. I understand that all legal costs towards the collection procedure of the above mentioned amounts shall be for my account.
- d. require full settlement of the total outstanding deposit amount together with all newly billed amounts (total outstanding invoice amount will become due immediately) on the current electricity and/or water account should Global International be forced to disconnect services due to failure on my behalf to keep to this binding agreement.

You further take cognisance that you will be exposed to prosecution in terms of the municipality's bylaws, enforced by Global International Meter Services CC, for the delivery of electricity and/or water, should illegal consumption of these services or any form of manipulation of the service installations take place at your address. In terms of section 45 of the Magistrates Court Act, 1944 ( Act 32 of 1944 ), as amended, you hereby agree to submit to the jurisdiction of the Magistrates Court relating to any action or process that may be instituted against you in terms of or arising from this undertaking. When signing this deposit downpayment agreement with us, you also agree to have a prepaid meter installed at your premises to cover Global International against any financial risks and losses that may occur. Any variation, relaxation, or waiver of, or addition to, deletion from or cancellation, whether consensual or not, of this agreement or any of the terms thereof (including this clause) shall be of any force or effect unless reduced to writing, signed by you and confirmed in writing by Global International Meter Services cc. You agree to elect the address above as your domicilium citandi et executandi.
