WITNESS NOW THEREFORE, in consideration of the promises and the agreements herein contained and intending to be legally bound hereby, the Parties do agree as follows:

The Purchaser hereby engages the DJ to provide a DJ Service. The service to be performed at Event Location:

The said DJ Service shall consist primarily of providing musical entertainment by means of a recorded music format. Tip Top Entertainment hereby agrees to render his professional services and is at all times to have complete control of his program.

A non-refundable reservation fee of \$300.00 is required to secure the services of Tip Top Entertainment for the engagement. This amount shall be applied toward the Performance Fee.

The Performance Fee is \$700.00 for the three-hour time frame outlined above.

Services requested that exceed the three-hour time frame will be charged at the rate of \$100.00 per hour, payable the day of the engagement. It may not always be possible to provide additional performance time.

Additional Terms and Conditions

The agreement of the DJ to perform is subject to proven detention by accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If such circumstances arise, all reasonable efforts will be made by Tip Top Entertainment to find replacement entertainment at the agreed upon fees. Should Tip Top Entertainment be unable to procure a replacement, Purchaser shall receive a full refund. Purchaser agrees that in all circumstances, Tip Top Entertainment liability shall be exclusively limited to an amount equal to the performance fee and that Tip Top Entertainment shall not be liable for indirect or consequential damages arising from any breach of contract.

It is hereby further agreed; that the Purchaser shall be held liable for any injury or damages to the DJ, or property of the DJ, while on the premises of said engagement, if damage is caused by Purchaser or guest, members of his organization, engagement invitees, employees, or any other party in attendance, whether invited or not.

In the event of non-payment, Tip Top Entertainment retains the right to attempt collection through the courts. Purchaser will be held responsible for all court fees, legal fees, and collection costs incurred by Tip Top Entertainment. Purchaser shall be charged \$25 for each bounced check plus a \$7.50 service charge for each collection notice.
