# To apply, the following is required:

- Each person, 18 years of age and over, must fill out a complete Savior Property Management application
- SPM supports Fair Housing Laws and is an Equal Opportunity Employer.

- Applicant is required to fill out both pages and sign the second page.
- A \$30 application/processing fee must accompany this application

- SPM reviews income, credit, rental, or home ownership to qualify applicants please read the SPM Application Instructions. If you do not have a copy of the Application Instructions, please ask SPM for one.
- Applicants must list all intended residents below.
- SPM requires listing of all animals/pets of any size, kind, or type. If you have an animal/pet, contact SPM to find out if this property can have animals/pets.
- If the owner allows animals/pets in the property, there is an increase in the security deposit per pet/animal on a case by case bases.

- All persons 18 and over must sign the rental agreement, and supply a current ID at time of signature. A signature is required of any approved cosigner as well.
- If SPM approves the applicant and the applicant defaults on the requirements of renting a property, SPM reserves the right to deny this application.
- If approved, the applicant must complete a walk through inspection prior to occupancy.

SPM will notify applicants of denial as soon as practical.
