
Please read the following in	formation carefully before completing the application form:
Who fills in this form?	Fill this form in yourself if you are 16 years of age or over. If you are under 16 years of age then one of your parents must complete the form on your behalf. Applicant = person being registered Claim parent = parent who is a New Zealand citizen otherwise than by descent (if both parents are New Zealand citizens you can choose either one).
Who may be registered as a New Zealand citizen by descent?	Any person born outside New Zealand on or after 1 January 1978 and whose mother or father was a New Zealand citizen otherwise than by descent at the time of that person's birth or adoption.
How do I know if my mother or father was a 'New Zealand citizen otherwise than by descent' at the time of my birth?	In general, to be a New Zealand citizen otherwise than by descent your mother or father will have been either born in New Zealand or will have received a grant of New Zealand citizenship before you were born. There are other ways that a person can be a New Zealand citizen otherwise than by descent. The Citizenship Office can provide more information concerning these.
What does registration do?	Having your citizenship by descent registered confirms that you are a New Zealand citizen by descent. It also provides evidence of your citizenship for passport and other purposes.
How long will it take?	Processing an application takes 20 working days on receipt of a complete and correct application, except for overseas adoptions. Please note the application is not correct until any required documents are received and translations are completed. Extra time should also be allowed for delivery to and from the Citizenship Office. Applicants are advised not to confirm travel arrangements until they receive their passport documents.
ls my father named on my birth certificate?	If your father is not named on your birth certificate, and the claim for citizenship is through your father, paternity will need to be established. Please contact the Citizenship Office.
Was I adopted?	A person who has been adopted outside New Zealand by a parent who is a New Zealand citizen otherwise than by descent may be a New Zealand citizen by descent. The adoption must fulfil severa criteria. The Citizenship Office of the Department of Internal Affairs will be able to provide you with information concerning the criteria and any other documents required.
Documents in a language other than English	All documents not in English must be translated and original documents must be sent in with the English translation. We will accept official translations of documents into English by the issuing Government agency. In addition, we will accept translations made by a court in the country of origin if they have been authenticated by that country's diplomatic post in New Zealand. International language documents (multi lingual) are available from many countries.
	If you need an English translation, the Department can arrange this through the Department of Internal Affairs Translation Service. Please include NZ\$75.00 / AU\$65.00 / GBP£35.00 for each document that requires translation. The Citizenship Office will organise an official translation, which will be returned to you with your documents.
	Alternatively, you may contact one of the agencies approved by the Citizenship Office to provide translations. A list of these can be found on our website <u>www.citizenship.govt.nz</u> or you can contact our office.
Will my children be New Zealand citizens?	The registration of your citizenship confirms and provides evidence of your status as a New Zealand citizen by descent. It does not enable you to pass on New Zealand citizenship to any children that you may have who are born outside New Zealand.
	You may wish to contact the Citizenship Office to determine your eligibility to apply for a grant of New Zealand citizenship. Any children that you have who are born outside New Zealand after you have received the grant of citizenship may have a claim to New Zealand citizenship by descent.
Fee	The fee of NZ\$204.40/AU\$180/GBP£100 provides for the registration and issue of one certificate of New Zealand citizenship by descent. We are not authorised to issue refunds once the application has been lodged with the Department. The fee is for investigating the claim and is not dependent on the outcome.
Applying from overseas	Unless a courier fee is paid by the applicant all documents to be returned to an overseas address (outside the country in which the application is lodged) will be sent by standard air mail (which is unsecured and untraceable). For confirmation of the price please contact the Citizenship Office in the country in which you are applying.


