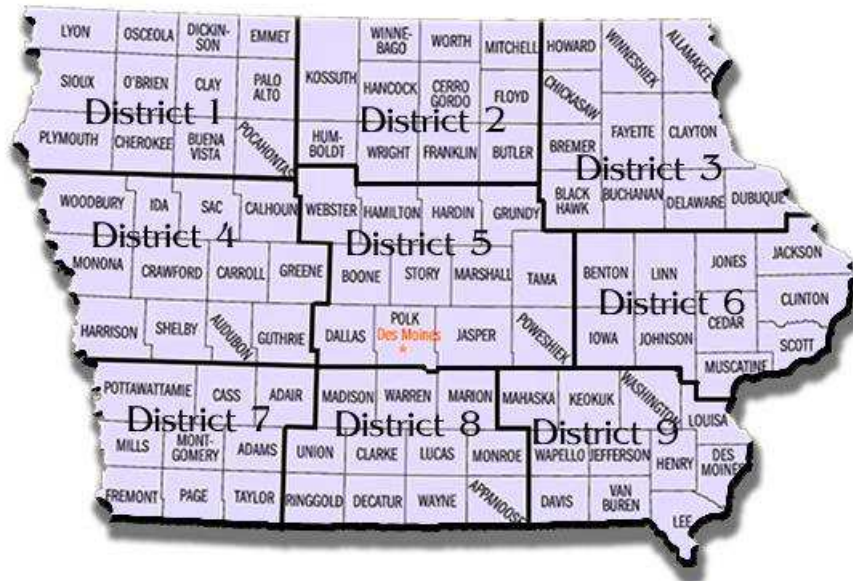

## MIDWEST AREA EXECUTIVE REPORT

November 2009

70 degrees in November, I think that means the average temperature for November has probably been higher than the average temperature for September! I know the farmers in my area have welcomed the nice weather with open arms and have been going strong in the fields.

This fall has been very active and I anticipate that it will continue to be busy for all of us with delayed harvest of corn and soybeans, DCP sign up, and the signup for 2008 SURE.

The NASCOE Execs and Officers are preparing for their fall meeting with management the week of November 16<sup>th</sup>. The purpose of the meeting is to follow up on Negotiation Session items that action was to be taken on after the spring session, to get answers to unanswered questions from the National Convention, and to address new issues with the FSA Management.

Some of the biggest issues that will be discussed with management are the problems with the new payment process, NRRS, the implementation of the Activity Reporting System (ARS), training, and the status of PT reclassification. Needless to say there are a lot of things to discuss during our short time in Washington. I do however look forward to the opportunity this meeting provides us to meet with FSA Management.

Back in August most of our department heads had just been appointed and had very little knowledge of FSA and what it does let alone who NASCOE was. After a busy three months, we hope the FSA administration has gotten on its feet. I was impressed with the message from the Administrator earlier addressing some of the biggest issues that have impacted the way we do our jobs. This shows me that management will be willing to listen and be open to suggestions to ways that will allow us to do our jobs better and more efficiently.

I would encourage all members to make suggestions through the NASCOE programs committee and negotiation process to all us to meet those challenges we run into every day. Submission forms for both the Program Committee and Negotiation Items can be found on the new NASCOE Website.

I also want to encourage everyone to watch the legislation that is being debated by congress. NASCOE has sent out an alert through Cap Wiz explaining our position on health care and that any changes protect our existing health program benefits.

The Administrator addressed the challenges that all of USDA will be facing because the tight budgets and the pressures they are facing to work within the budget they have been provided. We all are aware that it costs more to operate today than it did a year ago. NASCOE will be vigilant in its effort to work with management in addressing how this will impact County Office staffing, benefits, and service to our customers.

## New NASCOE Group Dental Plan

J. M. Marketing has secured a new dental plan for NASCOE members. Enrollment is so simple and can be accomplished on line at [www.nascoebenefits.com](http://www.nascoebenefits.com) or by paper enrollment. Forms can be printed from that same website.

This year, members have the opportunity to enroll with no waiting periods for covered services. Most plans require a 12 month waiting period for certain services. The new plan allows you to use a dentist of your choice. However, if you select a network dentist, services are discounted from 20% to 30%.

The dental plan is through First Continental Life and covers 100% of preventive services as well as 80% of basic services and 50% of several types of major procedures. The plan includes coverage of 50% of orthodontic expenses up to \$1500.00 to age 19. The calendar year deductible is \$50.00 per person or \$150 maximum per family.

**IASCOE** will again this year be offering 4 scholarships to high school seniors, graduates, or full time college students, up to the Bachelor Degree level. (Full-time is a minimum of 12 credit hours). Eligibility requirements are a minimum of a “C” average (using the 4.0 system) in **both** junior and senior years of high school or as a college student. These scholarships are worth \$300 and are paid after the completion of the first semester of post secondary education. The applicant must be a legal dependent of an **IASCOE** member, a member’s spouse, or even be an **IASCOE** member. The **IASCOE** member must be a county FSA employee with membership during the last five consecutive years or has been a member since becoming a permanent FSA county employee, including the current year.

If you or someone you know is an active member and will have a college bound student or has a student currently in college, take advantage of the **IASCOE** scholarship program. ## IASCOE Legislative Report December 2009

Did you receive the CAP WIZ informational message regarding the FERS sick leave provisions in the Defense Bill signed by the President? If not, are you wondering why you didn't? Iowa has 225 subscribers to the CAP WIZ legislative alert system that NASCOE provides as part of the legislative process. That is just a small percentage of our IASCOE members. Unfortunately not all of our subscribers have even sent the alerts as they are notified. There is a current alert regarding Health care reform that is now active and going to Senators only. So far Iowa has only had 94 respond sending 208 letters. If you are wondering why that isn't 188 letters (2 Senators X 94 subscribers taking action), that is because some changed the name and sent for a spouse. Our system only looks at email address it is coming from so it appears that the email address has sent the letter twice. Just a reminder, you may only get one response from that senator's office. If you have changed your email address or mailing address, please get to me the new information and I will update in the system. #### **FERS Sick Leave included in Defense Bill**

NASCOE's Members are heard

#### FERS Sick Leave

On Wednesday, October 28, 2009, President Obama signed into law the Fiscal Year 2010 Defense Authorization bill, which includes several benefit improvements long sought by NASCOE and other professional employee associations, including the National Association of Retired Federal Employees. NASCOE applauds the efforts of legislators and the President for their part in this beneficial change for employees and hearing the collective voices of the professional associations who have supported the legislation

The new law allows:

federal agencies to re-employ federal retirees on a limited, part-time basis without offset of annuity;

Federal Employees Retirement System (FERS) workers to initially credit half, and in 2014 all, of their unused sick leave toward retirement;

Currently, employees covered by the Civil Service Retirement System are allowed to credit their unused sick leave toward their retirement annuity. FERS employees did not receive any benefit from unused sick leave upon retirement. NASCOE has been working behind the scenes to end the inequities under the two retirement systems, which has hurt productivity and increased agency costs.

This new provision gives employees greater flexibility in the way to use their sick leave to best serve their needs, whether they need the leave for immediate medical concerns, "short term disability" to recover from a debilitating disease or if they choose to take the monetary benefit from leave that was not needed during their career.

Concerns over budget resulted in the compromise of phasing the sick leave credit in gradually until 2014.

Jim Moran, (VA) has carried the torch for federal employees on this issue and deserves the majority of the credit for consistently keeping this before the leadership. A big THANK YOU and job well done is extended to all of those persons that sent Cap Wiz letters, presented this idea at the legislative conference and continued to stay in touch with their representatives on this issue.

## SUGAR COOKIES

1 c butter (softened)	2-1/2 c flour
1-1/2 c powdered sugar	1 tsp baking soda
1 egg	1 tsp cream tartar
1 tsp vanilla	¼ tsp salt

Cream butter and sugar. Beat in eggs and vanilla. Sift together flour, soda, cream tartar and salt. Add to creamed mixture. Chill dough until firm. On floured surface roll out dough, cut shapes and sprinkle with sugar. You might have to add a little flour when rolling out, the dough may be sticky. Be sure your surface is well floured. Bake for 6 – 8 minutes in a 400-degree oven. Frost with powdered sugar frosting tinted with the Christmas colors of your choice. Hint: I use almond flavoring in my frosting, instead of vanilla. It gives the cookies a different flavor and everyone loves them!



## Powdered Sugar Frosting

6 TBS Butter	1-1lb powdered sugar
1 ½ tsp almond flavoring	Milk

Cream butter; gradually adding about ½ of the powdered sugar. Beat in the flavoring and a couple TBS milk. Gradually add remaining powdered sugar. Add the milk gradually in order to get the consistency you want for spreading. I leave it thicker and some like it to be thinner.

Separate the frosting into separate bowls so you can add food color as desired. Frost and sprinkle with colored sugars, cinnamon imperials etc as you like.

## HORNETS AT THE TERHARK HOME

Our family was walking to Church one beautiful late summer Sunday morning when I noticed a large batch of bright red leaves on a large tree planted in the cult de sac next to our house which seemed odd since the rest of the tree had bright green leaves. We were walking around the tree when we spotted it – the largest hornet nest that I had ever seen.

That afternoon we notified the neighbors of the nest to prevent any possible accidents that could occur with several hundred hornets hanging in the tree and many rambunctious kids throwing footballs and baseballs in the area very close to this location. The guys were in a huddle determining how many cans of Raid it would take to allow one person to climb a ladder and remove the troublesome nest. Deep in my mind I didn't care how many cans of Raid it would take because I wanted it. I could picture the gigantic mass of horror hanging from my mantel in the basement so every evening that I went down to watch the big screen TV, I could remind myself of my heroic act. The problem was the hornet's nest was hanging on a tree in common ground which means that no one really owns it. This told me that the first person to get it keeps it. I also knew that the weather was too warm to try to pluck it from the tree with hundreds of angry hornets flying around, so I needed patience – which isn't easy for me to come by.



After several weeks of eying the nest every night coming home from work I had an evening where I anticipated doing a project that I could not complete so I thought "Tonight is the night that I get the nest." Needless to say it was dark by the time I was ready to start the project, but I didn't care. The temperature was around 40 degrees so I thought the hornets would be a little slow. I put a coat and gloves on to reduce the amount of skin exposure I had in case something bad would happen – like having hundreds of hornets flying out at me. I asked for Joni's assistance and handed her the only Raid can that I had for use in case things turned out a little sour. She had a few choice things to say as we were going out the door.

It was dark so I needed a flashlight, and after careful observation I figured out a way to get the hornet's nest down. I have a ladder like you see at the fair which can be set up in a hundred different ways of which I have only figured out two, so I expanded that as high as it could go and carried it out to the hornet's nest. I thought that by climbing up the ladder I could cut the nest down. I noticed the first problem - the ladder was shorter than the height of the nest. Not a problem, thought I. I have one of those saws on a pole for cutting down high branches. I'll just use that. 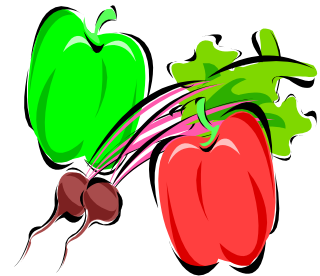

## JOHN BAHNSEN (FLOYD COUNTY CED) HAS A VERY TALENTED WIFE!

CHARLES CITY - Some women daydream about luxurious vacations, sleeping in, a romantic rendezvous.

Kim Bahnsen's thoughts often stray to adrenaline-pumping plots that involve new and creative ways to off someone. She gets caught up in the details, like where to hide the body. Her imaginative tidbits aren't all gloom and doom; the incessant "what if-ing" eventually leads to a steamy love scene or two.

Bahnsen, 52, of Charles City, isn't planning a life of crime and passion. Rather, the elementary school teacher, wife and mother of five, also is a published writer with a very active, if at times morbid and racy imagination. The award-winning author of almost 30 books, Bahnsen - who writes under the pseudonym Kylie Brant - is finding success in the romantic suspense genre.

And only in recent years did she discover that not everyone walks around with a running plot line in their head. Now that was a shocking discovery.

"I thought everybody had those," Bahnsen quipped.

"Even when I was a kid ... I'd just sit back and it's like I had a little movie reel going," she added.

Bahnsen's new romantic thriller series, "The Mindhunters," is being released this fall by Berkley Sensations, a line of the Berkley Publishing Group, part of the Penguin Group. "Waking Nightmare," which debuted in September, follows a forensic profiler and a police detective as they trail a serial rapist who customizes his torturous schemes to reflect each victim's worst fears. "Waking Evil," released Tuesday, and "Waking the Dead," due out Nov. 3, are also tales of crime, adventure and lust.

At least three more novels are planned for the series.

The new series with a new publisher is a deliberate step toward the dark and sinister. Bahnsen strives to write the types of books she can't always find on the shelves: gritty, edgy, intelligent and suspenseful stories topped off with a satisfying romance. Her first stories crafted for Silhouette Intimate Moments included elements of intrigue but always prioritized the love story.

"I'd always try to push suspense and they'd say more romance," Bahnsen said.

Bahnsen said she started writing in 1990 out of desperation. After completing a master's degree in special education, Bahnsen decided to treat herself to some light reading.

"I decided I didn't want to read anything intelligent for a year," she said.

When her favorite authors couldn't write fast enough to satisfy her voracious appetite for fiction, Bahnsen started writing her own. She finished a manuscript, called a publisher, and was informed by a "very snooty receptionist" that she wasn't following protocol.

But Bahnsen persisted and her second manuscript, and then her first, eventually sold after some major revisions. Today, she has her hands full spitting out plots fast enough for Berkley.

In April, Bahnsen received a Career Achievement Award from Romantic Times Magazine. In July, she won the overall Daphne du Maurier award for mystery and suspense.

Factual accuracy is important to Bahnsen, who takes the time to run her ideas by police sergeants and crime lab managers. She also uses the Internet to track down a former hostage negotiator and SWAT team trainers.

Bahnsen's husband, John, is proud of his wife's success, and the couple joke that her obsession with murder can make for interesting, if uncomfortable dinner conversations.

"She's worked hard at it," he said.

Bahnsen's agent, Danielle Egan-Miller of Browne & Miller Literary Assoc. in Chicago said the author has the skill and the dark imagination to find her place in a larger market. Bahnsen's characters are relatable, interesting and sexy, Egan-Miller said.

Bottom line? Bahnsen is a talented writer who tells a good story.

"Iowans should be proud of her," Egan-Miller added.

Virginia Ruzicka, head librarian at the Charles City Public Library, is impressed with Bahnsen's phrasing and vocabulary in books that also are easy to read. Plus, she vouches that the author is a nice person.

"She's got quite a good following here in Charles City ...," Ruzicka said.
