The CDA is a national early care and education credential for teachers and caregivers of children ages 0-5 who work in licensed childcare centers and registered family childcare homes and is awarded by the Council for Professional Recognition in Washington, DC.

Ideal Early Learning Registration Policies:

- **Registration and payment must be *received by the deadline date – September 30, 2013.***
- *On-site registration will NOT be allowed. Please register in advance.*
- A \$30 fee will be charged for returned checks.
- **Refund Policy:** Notice of cancellation must be received by 5 business days prior to the training. No refunds or credits will be made after that date. If you cannot attend, you may send another participant in your place. Should you choose to cancel your registration, you may choose from the following options: (1) full credit for a future Ideal Early Learning training or (2) refund minus a \$25 handling charge. *Remember, the deadline for any registration changes is 5 BUSINESS DAYS prior to training date.*
