DESCRIPTION OF REQUIREMENTS

- 1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the provision of Travel Management Services which includes Official Travel as well as the rotation of the Military Contingent. The resulting contract would be for an initial period of one year with an option to extend for three one-year periods.
- 2. As part of Travel Management Services, the contractor shall provide travel services required for the UNFICYP's Official Travel of approximately 400 travels per annum to various destinations.
