The Sumter City-County, Shaw Air Force Base (AFB), and Poinsett Electronic Combat Range (ECR) Joint Land Use Study (JLUS) is a cooperative planning effort conducted as a joint venture between Shaw Air AFB, including the Poinsett ECR, the City of Sumter, Sumter County, and other affected stakeholders. 


Shaw AFB Study Area
