Excludes incidents in which the intent of the sexual contact is to harm or debilitate rather than sexually exploit.</p> <p><i><b>Youth-on-Youth Sexual Harassment</b></i> -- Includes repeated resident-on-resident verbal statements or comments of a sexual nature; repeated profane or obscene language or gestures; repeated requests for sexual favors; and/or demeaning references to gender or derogatory comments about body or clothing.</p>

Sexual relationships of a romantic nature between staff and youth are included in this definition. Consensual or nonconsensual sexual acts include: Intentional touching of the genitalia, anus, groin, breast, inner thigh, or buttocks with the intent to abuse, arouse, or gratify sexual desire; completed, attempted, threatened, or requested sexual acts; and/or occurrences of indecent exposure, invasion of privacy, or staff voyeurism for sexual gratification.</p>

**Staff Sexual Harassment** -- Includes repeated verbal statements or comments of a sexual nature to a juvenile or youthful offender by an employee, volunteer, contractor, office visitor, or other agency representative (exclude youth family, friends, or other visitors); repeated profane or obscene language or gestures; and/or demeaning references to gender or derogatory comments about body or clothing.
