Rebate Limit	One rebate per combination of wireless number and IMEI (serial number)
Purchase Requirements	Wireless service must be maintained for a minimum of 3 months and must still be active at the time of rebate payout. Wireless number submitted for rebate consideration must match the phone number used on purchase receipt. New 2 year contract is required. One rebate form, copy of receipt and copy of IMEI barcode is required for each eligible handset purchased.

To receive your Cincinnati Bell Wireless rebate, follow these steps:

1. Purchase a Qualifying Smartphone Model with new 2 year contract during the valid purchase dates.
2. Include a copy of the UPC/IMEI barcode label from the side of your phone's box when you mail this rebate form. See label sample.
3. Keep your Cincinnati Bell account in good standing and maintain your wireless service subscription for a minimum of 90 days after your purchase. Your wireless number must not be suspended or cancelled at time of payout to qualify.
4. Mail a copy of your receipt or invoice, copy of your UPC/IMEI barcode and completed offer form to the address below. Submissions postmarked late do not qualify.
