Mickey Sparrow, CMRP, FAHRMM is the Material Manager of Tuomey Healthcare System, a 301-bed acute care facility located in Sumter, South Carolina. A native of Bartow, Florida, he retired in 1995 after completing a 20 year career in the US Army. He joined Tuomey in 1996 and worked as a Supply Technician, Buyer, Contract Manager and Assistant Director before assuming the role of Material Manager in 2001. He is a former President of the South Carolina Society of Hospital Materials Management and began a three year term on the AHRMM Board of Directors in January 2011. He is currently co-chair of the Medical Materials Coordinating Group.

Steve Curren is Deputy Program Manager of the Critical Infrastructure Protection (CIP) program of the U.S. Department of Health and Human Services (HHS). The HHS CIP program is housed within the Office of Preparedness and Emergency Operations under the Assistant Secretary for Preparedness and Response. Mr. Curren arrived at HHS in December 2008 after working five years at the Association of State and Territorial Health Officials (ASTHO), where he served as Senior Director for Public Health Preparedness. Prior to joining ASTHO he served four years as an industry consultant on public health and regulatory issues, including one year consulting on European regulatory affairs in Brussels, Belgium.
