#### About the Project

The Supporting Networks of HIV Care (SNHC) by Enhancing Primary Medical Care project is a national, technical assistance and capacity building project designed to develop, improve, and expand comprehensive HIV primary medical care and treatment service delivery in racial/ethnic minority communities severely impacted by HIV/AIDS through providing technical assistance (TA), intensive capacity building (ICB), and training to primary medical care sites. The project is evaluated to assess its immediate, short-term, and long-term outcomes, ensuring that the training and technical assistance has a measurable impact on the development, improvement, and expansion of high-quality HIV primary medical care for people of color. Funded by the Health Resources and Services Administration (HRSA)'s HIV/AIDS Bureau, the project is managed by HealthHIV.

HealthHIV is a national, non-profit organization providing on technical assistance and capacity building to primary care providers engaged in, or seeking to engage in, HIV care and treatment. Our mission is to advance effective prevention, care and support for people living with, or at risk for, HIV by providing education, technical assistance and health services research to organizations, communities and professionals.

#### Training

By conducting in-person trainings, we seek to increase the capacity of participants from eligible primary medical care sites to provide HIV primary care through in person meetings, web-based trainings, and the awarding of Continuing Education Units (CEUs).

Eligible participants will be selected from \*Public Health Service (PHS) Regions 7, 8 and 10 (*lowa, Kansas, Missouri, and Nebraska, Colorado, Montana, North Dakota, Utah, Wyoming, Alaska, Idaho, Oregon, and Washington*). The cohort will participate in two (2) in person trainings, the first will be held in Seattle, Washington, the second in Washington, DC. In person trainings are on topics essential to the implementation and/or expansion of HIV primary care services within a primary medical care site. The training sessions will consist of general session topics and track specific sessions in the areas of clinical, program, and administrative practices. All candidates who successfully complete their participation in the Trainings will be awarded CEUs.

#### Scholarships

Eligible participants can apply for a scholarship to attend the in person trainings. Scholarships will cover the following: lodging, travel, approved ground transportation, and meeting materials. #### **Training Topics**

Training will be conducted by multidisciplinary teams of consultants with diverse backgrounds and extensive experience in HIV primary medical care services delivery systems. Topics will include:

#### The Face of HIV: Yesterday, Today and Tomorrow (Plenary Session)

This session addresses the significance of the Supporting Networks of HIV Primary Care by Enhancing Primary Medical Care (SNHC by EPMC) project, providing an overview on the history and epidemiology of HIV, and address the impact of Ryan White Program funded HIV services. The session also reviews current trends and highlights future considerations.

#### Connecting to the Continuum: Linking Primary Care to HIV Primary Care (Plenary Session)

This session addresses the client's need when seeking HIV treatment in a primary care setting. The session examines the vital link between primary care and HIV and the importance of providing support services for HIV positive clients.

#### Case Management: Connecting Clients to Care (Program Track)

This session covers the importance of, and improvements strategies for, client documentation, the essentials of time management skills, the importance of planning, and teaches participants how to create a coordinated case management plan.

#### Counseling Testing and Referral (CTR) (Program Track Workshop)

This session explores the significant impact case management can have on patients taking an HIV test. This workshop looks ways program staff can structure HIV testing procedures to ensure patients receive important information, and when necessary, understand how to access healthcare services. The session identifies HIV testing methods, the importance of pre- and post-counseling, and the important role service referrals play in keeping HIV positive clients in health care.

## Administration of HIV Clinical Services: Implementing HIV Primary Care Services (Health Care Administrator Track Workshop)

This session addresses the resources needed to expand services to incorporate HIV into a primary care setting. This workshop, designed for health care administrators, looks at the vital administration issues at play in this process.
