Such inquires may be made to state and/or federal law enforcement agencies. Information obtained for the disclosure statement, or from the background inquires will not necessarily preclude appointment but will be considered in determining the applicant's character, suitability, and competence to perform in the position applied for and may result in denial of appointment. Use of the record of these inquires will be restricted to the decision on your application.

If you wish to be considered for a volunteer or staff position, you must complete and sign this Applicant Disclosure and Authorization for Background Inquiry form. Failure to complete and sign this form shall disqualify you for appointment in this position. A background check of civil adjudication, conviction records of crimes against persons, and final board disciplinary decisions may be conducted.
