- ☐ (4) The Lessee is authorized to collect, freeze, sell, and ship semen from this horse, during the period of this lease. Upon termination of the lease, any and all frozen semen becomes property of the stallion owner (Lessor).
- ☐ (5) Lease of the stallion above is for the purpose of riding, showing, driving, etc., and no rights of breeding apply. However, the Sugarbush Draft Horse Registry will consider and recognize the Lessee as owner, only for the purpose of showing and publication of any show results, during this period.

The Sugarbush Draft Horse Registry is authorized to accept the signature of the Lessee on all breeding reports and applications for registration of foals in cases of #1 and #3 above; in the case of #2 all documents must also have the Lessor signature.
