**RULES:** Proof of USFA membership is required. Existing USFA rules apply. Fencers must be born in 1990 or earlier. Proper uniforms (no sweatpants) are required.

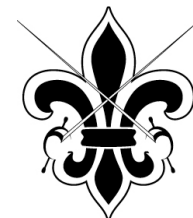

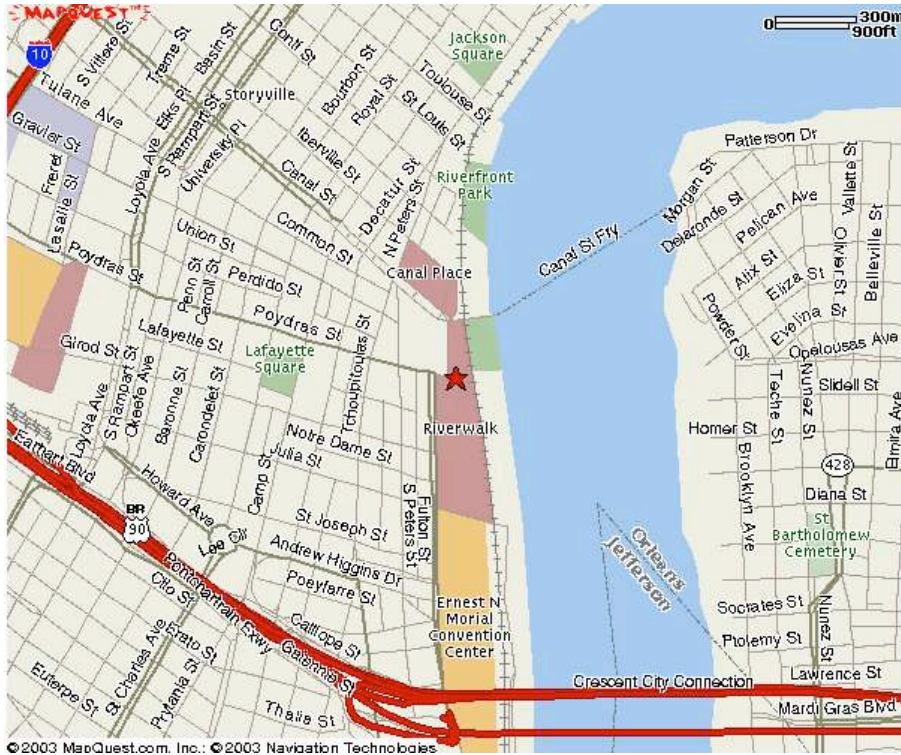

From West/ Follow Interstate-10 to Downtown/East/Slidell, exiting at Poydras St. Off-ramp becomes Poydras St., following Poydras south to its end at the hotel's front circle drive entrance. From East/Follow Interstate-10 Downtown/West, exiting at Canal St./Superdome. Follow signage to Superdome/Poydras St., turning left onto Poydras St. Follow Poydras St. south to its end at the hotel's front circle drive entrance.
