*Riders must have a current AMA Pro Racing license in order to submit an entry. Entries for the 2010 Lucas Oil AMA Pro Motocross Championship are limited to 90 riders each in the 250 and 450 classes. Riders may only enter one class per event. Riders must have an updated MX Sports Pro Racing Online Rider Profile in order to access online registration. Registration online is highly recommended in order to ensure deadline compliance.*

*Upon receipt of your entry:*

1. *You will receive an email confirming your entry has been" received". (Do not confuse this with acceptance into the event.)*
2. *The event entry deadline is 11:59 pm EST on the date as indicated on the chart below. Riders registering after this time will lose their entry acceptance priority once the event has been seeded. Entries received AFTER the deadline are subject to a \$50 late fee.*
3. *Once the deadline for entries is reached, classes will be seeded*
4. *We will issue an email within 72 hours notifying you either that your entry into the event was "accepted" or "denied".*
5. *If your entry was denied, you will receive a refund check.*
6. *All Notifications will be sent to the email addresses you have specified in your online Rider Profile.*

## **ENTRY TERMS AND CONDITIONS:**

### **LIABILITY WAIVER:**

By submitting this Entry Form, the participant (rider and team, and in the case of a minor, his/her parent or legal guardian) waives all rights and titles to any legal claim arising from any accident or damage caused in conjunction with his participation in the Event(s) against:

- AMA Pro Racing, MX Sports Pro Racing, its affiliates and related companies, their officers, directors, members, employees and officials;
- Organizer/promoter, his/their representatives, stewards and assistants, sponsors, advertisers, subcontracted companies, television producers and broadcasters;
- Owners of the property used for the Event, including structures and installation of the race course, and their representatives and assistants;
- Other participants (rider and team) and their attendants, as well as against his/their own assistants; and
- Authorities, sponsors, race services and any other organization or corporate or natural bodies involved in the organization of the Event.

The participant (rider and team, and in the case of a minor, his/her parent or legal guardian) accepts the conditions above and commits himself to comply strictly with them. Moreover, the participant accepts that if his health is affected in such a manner that his fitness for continuing in the Event has been put in question, regarding the safety risk also affecting third parties, he releases all doctors/medical providers in attendance from their obligation to professional privacy/secrecy towards MX Sports and towards the officials carrying responsibility of the Event (i.e., Organizer, Chief Medical Officer, Event Director, Referee, etc.). The participant (rider and team, and in the case of a minor, his/her parent or legal guardian) certifies that he is in good health and suffers from no illness or injury which impairs in any way his ability to participate in the Events. Participant shall notify MXS of any medical condition or change in his condition that could in any way affect his ability to participate in a safe and competent manner. Participant must comply with any request from MXS regarding evidence of medical condition. MXS retains the right to prevent rider from participating in the Event pending examination(s) to determine rider's medical condition or ability to participate in a safe and competent manner.

Participant acknowledges and confirms that neither MX Sports nor the Organizer provides Rider Medical Insurance, and urge the Rider not to participate without it. Rider further certifies the veracity of the information provide through this entry form. Rider declares to have a full and complete knowledge of the contents of the AMA Pro Racing Motocross Rules, and the specific terms and conditions set forth on this entry form, and commits himself to accept them and to comply with the directives and instructions of MX Sports, the organizers and the officials. Rider undertakes to communicate to MX Sports any changes to the current information on his online Rider Profile (personal data, etc.)

### **RESPONSIBILITY:**

By submitting this Entry Form, the participant (rider and team, and in the case of a minor, his/her parent or legal guardian) declares and recognizes that he takes part in the Event referred to in this Entry Form at his own risk. He bears the sole responsibility regarding applicable civil and penal laws and regulations for any and all damages caused by him or by his motorcycle arising from his participation in the Event. If the rider himself is not the owner of the motorcycle used by him during the Event, he releases all those persons listed in the preceding paragraph (Liability Waiver) from all claims which could be filed by the owner of the motorcycle.

### **IMPORTANT:**

By submitting this Entry Form, the participant (rider and team, and in the case of a minor, his/her parent or legal guardian) acknowledges and confirms that motocross, like all motorsports, can be dangerous, the risks of which cannot be completely eliminated. By participating in any Event, participant assumes the risk of property damage and serious injury up to and including death. Participant will have the opportunity to inspect and review any and all courses upon which Events are conducted, and must notify MXS officials of any conditions considered to be unsafe. Participation in the Events is voluntary, and participant waives any and all claims for personal property damage, injury, or death against AMA Pro Racing, MX Sports Pro Racing, Inc., the Event Organizer(s), promoter(s), owner(s) or any of their respective members and/or investors, directors, trustees, officers, employees, agents, personnel, as well as any of their contractors and/or consultants.

### **EXPLOITATION OF IMAGE RIGHTS:**

By submitting this Entry Form, the participant (rider and team, and in the case of a minor, his/her parent or legal guardian):

- Agrees that he will not videotape, film or otherwise record his/her performance in the Event or any portion of the Event, (or any practices or qualifying activities or any other activities associated or connected with such Event), in whole or in part, nor will he authorize or license any third party to do so, except Rider shall be permitted to take still photographs of the Event (and such practices or related activities), provided that his use of any resulting photographs will be solely for his own non-profit purpose;
- Agrees that MX Sports and its affiliates and designees shall have the right, in perpetuity throughout the world, to use the name, likeness and/or biography of the Rider in connection with the Event and all advertising and promotion of MX sports and/or any motor sports event or exhibition produced, presented or promoted by MX Sports;
- Grants to MX Sports and its affiliates and designees, in perpetuity and throughout the world, and without further compensation or consideration, the exclusive right to photograph, film, videotape, or otherwise record and to use, reuse, license the right to use and reuse, and to otherwise exploit in any manner whatsoever by means of print and any and all forms of electronic media distribution now existing or hereafter created (including without limitation standard and non-standard television and home video distribution):
