NOTE - T-shirts will be given to only 10 players on 1st place <u>division</u> winning teams. Captains are responsible for contacting the Adult Sports staff with player sizes within 2 weeks of the last season game in order to receive the t-shirts. Team trophies are awarded for <u>tournament</u> 1st place only

For the sports staff to fairly and effectively determine which teams will play, we have established a team limiting procedure. Complete roster registration information is the basis for this procedure. *Please read the following and acknowledge that you understand.*

- 1. Submit this form within 5 days of registering your team online. A complete roster must include the following:
 - Player's first and last names; Signature on the Liability Waiver, Player's **HOME** address, including street #, street name, **CITY** and **ZIP CODE**; Player's **DAY** phone numbers.
- 2. Online registration dates will be posted on the main Volleyball web page. Payment must be submitted at the time of registration. No exceptions!
- 3. If you request days of play, please understand:
 - A) We **CANNOT** guarantee your team will be scheduled on the night requested.
 - B) To accommodate the requested day of play, we may need to place your team in a higher division.
 - C) If your team is not accepted into our league a full refund will be issued. Refunds may take up to 30 days to process depending on the method of payment.

FALSIFICATION OF INFORMATION

The Adult Sports staff will be making spot checks on each program roster using the following guidelines:

- 1. Rosters of all teams accepted will be checked.
- 2. Random selections from various rosters will be verified.
- 3. Teams that submit falsified information will be dropped.
- 4. Teams that fail to supply a roster or submit incomplete rosters will lose priority in the team selection.

CITY OF SCOTTSDALE PARTICIPANT CONDUCT POLICY

- Any physical assault upon an official, staff member, player and/or spectator will result in automatic suspension, which
 may be extended for up to a lifetime as deemed proper by the Sports Coordinator and Sports Staff. This also includes
 any inappropriate behavior, verbal or physical abuse, towards officials, staff, players and/or spectators, on or off the
 court, prior to, during, or after a game.
- 2. Obscene and/or abusive language, threats, and other unsportsmanlike acts are grounds for player and/or coach ejection and/or suspension and/or game forfeiture. Future game suspensions will be determined by the Sports Coordinator after reviewing the circumstances of the player(s) ejection.
- 3. Once ejected from a game a player must not only leave the playing court, but the facility area as well. Actions of the player(s) once ejected are still the responsibility of his/her team. Teams are also responsible for the conduct of their spectators.
- 4. Any player/person ejected from their game will also be suspended for at least the following weeks scheduled games. If the next weeks scheduled games are postponed for any reason, the suspension will be for the next scheduled games. The Adult Sports Staff will determine the severity of the suspension, which could be up to a lifetime depending upon the severity of the situation. The suspended player/person will not be allowed at the complex, park or facility while serving their suspension.
- 5. For safety/liability purposes, any non-playing personnel (other than coaches and scorekeepers), which include children and pets, will not be allowed to sit in the player bench area and must be supervised by non-playing adults. No one under 18 years of age or pets will be allowed on the playing court.
- 6. Consumption or possession of alcoholic beverages is prohibited by players and spectators during league and tournament games. Violation of this rule may result in players' ejection, suspension, and/or game forfeiture.
- 7. Players noticeably under the influence of drugs or alcohol will be ejected from the game and facility. Failure to abide by this rule may result in game forfeiture and player(s) suspension.

CITY OF SCOTTSDALE PARTICIPANT BEHAVIOR POLICY

The Parks and Recreation Division will not tolerate any form of discrimination, abuse, and/or unacceptable behavior. Unacceptable behavior includes, but is not limited to, the following:

- Any violation of federal or state law, or city ordinance.
- Deliberate or reckless disruption of any park activities or programs.
- Failure or refusing to obey park/facility ordinance or park/facility rules as directed by city staff or sign.
- Threatening or intimidating others through verbal abuse, profanity, obscene gestures, or other means
- Intentionally or recklessly damaging or defacing any park property or equipment, or personal property of others
- Fighting or other assaultive behavior

Further, I agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the field arranged for by the team or league: 1) I voluntarily elect or accept and solely assume all risk of damages, injury, including death, incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member or observer during practice or play by other teams or by other players on my team, and (c) while on or upon the premise of any and all of the fields/courts arranged for by my team or league for practice or play. 2) I release, discharge, and agree not to sue the team and/or league designated below, the City of Scottsdale, or any owner or lessee of fields/courts on which adult sports is played or practiced by my team or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field/court for any claim, damages, costs, or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract, or wrongful conduct of the parties hereby released. I further agree that I shall hold harmless and fully indemnify the parties hereby released from any claims, damages, costs including attorney fees, and cause of action which may arise from any claim or cause of action made by me, through me or on my behalf even if the damages, injuries or death are caused in whole or in part by any of the parties or entities hereby released. Participants understand and agree that they may be photographed and/or videotaped for promotional purposes.
