BY THE COMMISSION:

By letter dated October 21, 2008, Qwest Communications Corporation, holder of Competitive Local Exchange Certificate of Public Convenience and Necessity No. 5801, requested that Certificate No. 5801 be amended to reflect the new corporate name, Qwest Communications Company, LLC. Upon review of the Department of State, Division of Corporations' records, it appears that Qwest Communications Corporation has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 5801 to reflect the new corporate name.

This Order will serve as the amended Competitive Local Exchange Certificate of Public Convenience and Necessity No. 5801 for Qwest Communications Company, LLC. Qwest Communications Company, LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Qwest Communications Corporation to change the name on Certificate No. 5801 from Qwest Communications Corporation to Qwest Communications Company, LLC is hereby approved. It is further

ORDERED that this Order will serve as Qwest Communications Company, LLC's amended certificate and that this Order should be retained as evidence of the name change. It is further

ORDERED that this change will be effective upon issuance of this Order. It is further

ORDERED that this Docket is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
