**The above named group agrees to the following terms and conditions;**

- 1) Camp rental is \$200.00 a day, with a security deposit of \$100.00. A non-refundable minimum payment of \$100.00 per week, for sump clean out. Deposit which must be received one month prior to arrival date.
- 2) Please drive slowly and abide by all camp rules and regulations.
- 3) All lake and beach activities are strictly AT YOUR OWN RISK.
- 4) All outdoor fires require a permit by the park office.
- 5) NO pets, alcohol, illegal drugs, smoking, firearms, explosives, or fireworks.
- 6) Damages due to abuse or misuse will be the responsibility of the renting party.
- 7) The camp must be left in a clean condition, or the security deposit will be forfeited.
- 8) Activities past 11p.m. shall be quiet enough to not be heard beyond the camp property.
- 9) Keep all buildings and facilities clean and orderly
- 10) Prevent destruction and disruption of trees, plants, and natural growth on camp property.

Assume responsibility for damage or injury to the group's participants, the property, and structures arising from the group's use of the facilities or activities organized by the above named group.

- 11) Cancellations must be made at least 14 days in advance, or the security deposit will be forfeited.
- 12) All garbage to be in large black bags (provided) and put in trash in behind washroom.
