## **Volunteer Driver 2013-2014 School Year Registration Packet**

I plan to volunteer this school year as a driver for the Palm Valley School for any School sponsored event or field trip.

I understand that I shall assume responsibility for the children I transport from the time we leave school until we return while they are in my car.

I understand that it is my responsibility to ensure that all children riding in my vehicle are secured with a seat belt at all times, there will be no double seating. In addition, I understand that children must be secured in an appropriate child passenger restraint (safety seat or booster seat) in the back seat of the vehicle until they are at least 8 years old or weigh at least 80 pounds. I also agree that my vehicle will be safe operating condition.

I understand that I have to carry the minimum of \$100,000/\$300,000 liability vehicle coverage and agree that this coverage has to be in place at all times during the course of volunteering to drive and while transporting students.

I understand that in the event of an accident, my insurance company is the primary agent liable for suit. Palm Valley School provides no insurance protection for physical damage to my vehicle or loss or damage to its contents.

I agree to release the school from any and all liability for property damage to my car or any of its contents, and any and all liability that results from an accident or incident that causes bodily injury or property damage.

I further agree that the information provided on this form is true and correct to the best of my knowledge. I understand the School will require basic screening of my driving record on an annual basis. (No one may drive with citations valued at more than 2 points: a Driving Under the Influence or 1 at-fault accident).
