Minutes of the AGM on Oct 30, 2011: Correction needed – instead of 'lan Hayes/David Bates moved that we thank the auditor for work done, and appoint them for next year.' it should read 'lan Hayes/David Bates moved that we thank the auditor for work done, and get the finance committee to arrange for new auditors for next year.' A. Robinson/L. Hayes moved that the corrected minutes be accepted. Agreed.

The agenda was approved, with no further additions.

D. Bates/J. Phillips moved that the reports be received. Agreed.

It was pointed out that at this stage there is still no compliance officer.

One of our key Sunday School leaders in Kerikeri, Heather McVicar, is going to be moving to Taupo to follow husband Bob and his work. Thanks heaps for being with us these years, and best wishes!

Kaeo home group report needed the addition of Anthony Hayes to the list of attendees.

Further to the PPG report – Bill Fenton, as facilitator, has started helping by meeting with the architects already.

Steve Baker has set up a proposal to progress with Garry Looker, with his agreement, and we await approval from the Methodist Church.

Brian Stewart informed us that the sausage sizzle yesterday brought the total funds raised for the Girls' Brigade Fonomarae trip to the required amount. Well done!

lan Hayes moved a vote of thanks to our minister, Robyn, for all of the work she has done for and with us this past year. Seconded by us all with applause.

Robyn then thanked Alan for the number of reports written for the AGM – three. Applause.

J. Phillips/I. Hayes moved that we adopt all of the reports dealt with so far. Agreed.

Finance report: Question – How much finance is available for buildings and investment? \$4,250,000??

Answer – No! Just over \$4,000,000, remembering that the original plan is to spend \$1,750,000 on the new church, about \$1,000,000 on the funeral parlor, with \$1,000,000 otherwise invested.

It was explained that in the Balance Sheet under Land and Buildings Revaluation (under Net Assets) the figure is negative (-\$289,438) because the latest QV values put the values of properties down.

The auditor has qualified the approval of the accounts, so David Bates will pursue this with them for us.

- D. Bates/B. Stewart: that the financial statements be adopted. Agreed
- D. Bates/B. Stewart: that we thank the auditors and ask them to be our auditors for next year Agreed.

Appointment of Parish Councilors: A. Robinson/D. Paterson: that we appoint Arlene Purdie, Michelle and Kato Akau'ola, and newcomers Michael Tearle, Bill Wilson, and Paula du Plooy to Parish Council. Agreed.

Clare Murdoch is retiring (by rotation) – thanks a lot for the work done with us Clare! Val moved a vote of thanks to Jenny (and Jenny to Val!) for all the work done! We all agreed by applause!!

The meeting closed with the benediction and was followed by a shared lunch in the Hall.

PARISH COUNCIL

Rev Dr Robyn McPhail has been our minister for nine years now, and the Churches Together in Northland (CTN) Ministry Appointment Team met with our parish and parish council recently to discuss the possibility of extending Robyn's time with us. The Parish Council unanimously voted to extend Robyn's term for another five years. The questions and concerns expressed by the parishioners will be addressed by the Council and Robyn, and with God's help we will be better able to promote the Kingdom of God in our communities.

Last spring the internal walls of the Kaeo church had a face lift in the form of plastering and painting, so it no longer looks as though it is cracking up with stress and old age. It looks great! Unfortunately the concrete water tank was backed into with a tow bar recently, and hall bookings were cancelled until a temporary tank was put in place.

It is sad for everybody that the building of the new church facility in Kerikeri has not started yet. Parish Council is very concerned at the escalated cost and ongoing delays. The Property Planning Group report covers this saga.

The submission we put to the Eastern Community Board to allow felling of gum trees adjacent to Fairy Pools access before the access is sealed failed, unfortunately. Maybe we should try again when there is a new Community Board elected in October!?

Parish Council is pleased that a new Kerikeri Pastoral Team has been established, made up of Jessica Scott (convener), Sandra Crawford, Paula du Plooy, Ros Simpson, and Kay Blunkell, working in tandem with Robyn McPhail. Thank you for your commitment. May God be with you as you care for the Kerikeri congregation and community.

Peter MacKenzie, executive officer of UCANZ (Uniting Congregations of Aotearoa New Zealand), visited our parish in February. He addressed the Parish Council, encouraging us to ensure that our church has a common purpose and a strong sense of identity, especially endeavoring to engage with the youth and making the message of Jesus relevant for them. This is a challenge for all of us to address: Robyn McPhail as minister, Parish Council as leaders, and indeed all parishioners!

The two Mission Support Groups set up this year are still fledgling. They are the Awhi Maori group, of Pat Tauroa, Craig Ambler, Robyn McPhail and Alan Robinson; and the Kerikeri group of Jan Gough, Paula du Plooy, the Akau'olas, Sheryl Webster, Mary Fenton and Robyn McPhail.

More people are welcome to join either group – to help each other in each individual sphere of activity, and thus help out in our communities. Time will tell how effective these groups will be.

Unfortunately our parish treasurer, Arlene Purdie, became ill, so had to resign. You have done a splendid job for us, Arlene over the last decade. Thank you very much. Fortunately the Purdies' daughter Sue Campbell is able to step up and take over the position! Thank you Sue!

A good deal of secretarial work is being done for Parish Council by Jenny Phillips, and has been done for the last four years or so. Things like sending out papers needed for each of the meetings, reminders to get information in for those meetings, setting up

minutes in a standard format, etc. Thank you very much, Jenny. You have been doing it willingly and well! (Thanks, especially, from the incumbent, only temporary, secretary who only has dial-up!)

God be with us as we move forward as a parish – Jesus said he would be! Jesus said (Matt. 28: 19) "God authorized and commanded me to commission you: Go out and train everyone you meet, far and near, in this way of life, marking them by baptism in the threefold name: Father, Son and Holy Spirit. PROPERTY PLANNING GROUP

The Queen's description of her year, several years back, as her "ANNUS HORRIBILIS" is the one we could use for our last year.

The Building Consent (BC) was to be lodged in Oct-Nov 2012 but we thought we should wait until we had guaranteed access from Fairy Pool track.

This was taking so long we decided to lodge with the access of Kerikeri Road, which we did.

We asked Bill Fenton to help us by approaching Far North District Council (FNDC) to get on with finalizing the right of way (ROW), which he did. We then asked him to carry on helping us as we were struggling with the technical stuff. He agreed to this and has been a great help. In December we learned that the water supply was not sufficient for fire fighting after FNDC had told us earlier that it was sufficient. We then had to add in 17 tanks at a cost of \$80k. This delayed our BC application. We have since sorted the water shortage with out having to put in tanks. We then had to apply for an amendment to Resource Consent (RC) to get the entrance off the ROW, more time and cost small as it may be. FNDC then did a complete turn around on the sewage and we are now allowed to join the town system. Bill did all the work on this and we are very grateful.

The Building Consent was lodged then, in late April, then suspended till further information was supplied. We were then told that we could not use the ROW until it was formed and sealed. We thought we had agreed with council we would do the sealing after building so as not to damage the seal. However we have been told if we apply to Council we can probably get the okay to do it after we build.

CreativeSpaces put our job out to tender in late June, and tenders closed on 22 May. This was to be a milestone for us and had been eagerly awaited, but what a disappointment. Tenders came in 30% above their estimates: how a firm could be so wrong we could not figure.

We are still in the process of getting the tender price down working with the preferred tender.

Unfortunately Margaret Langman has had to cut back on her contribution and has resigned. Thank you Margaret for all the many years of various chores you have carried out for the church. Well done indeed!

The inside of the church is looking splendid now, having been plastered and then painted. Flood proofing has yet to be completed, a quote for it having recently been received.

This year the windows are all right, but the water tank was backed into with a towbar!! The tank is adjacent to a garage and service station, so the wonder is that it hasn't happened before.

A couple of hall bookings were cancelled, but a temporary tank has been put in place, so people can use the place again. The insurance people have decided that the old tank is not worth repairing, so will get another one put in. In spite of the job being called URGENT, that fourth fruit of the Spirit, PATIENCE, is having to be exercised! [By the time of printing of this report, the new tank is installed and rain-water pouring in.]

The Seventh Day Adventist Church and a Yoga class regularly book the hall. As well other organisations use it from time to time: NRC, the Runanga, Whangaroa Health Trust, and the Whangaroa Community Development Group. Weddings and Funerals that use the church also make good use of the hall.

The committee still has before it the long term possible solutions that Tilsley Engineering have suggested to fix forever the problem of the church being flooded from time to time. In the mean time short term fixing is still being actioned.

FINANCE

Results for the financial year (subject to audit) show a surplus of \$126,281, well down from last years result of \$154,505. Major areas of decline in income were Giving - \$5444, Interest Income - \$6087, Miscellaneous Income - \$9098, offset by increased new Church building donations and fundraising +\$3564. Expenses were generally in line with budget apart from Kaeo property maintenance +\$10,000. Kaeo property rents are noted to be improving.

As in previous financial years Giving is down both in Kaeo and Kerikeri overall by 14%, we rely on interest income to pay our way.

Committee members during the year were: Ian Hayes, Robyn McPhail, Arlene Purdie, Ray Webster, David Bates. Darroch Todd joined the committee early in 2013. In recent months we have lost Wynn Judd and recently Arlene Purdie resigned due to health issues. She has recently been replaced by her daughter Sue Campbell. Ross Renner continues as a consultant member receiving all email material and advising as appropriate.

Wynn Judd has been involved with the Finance committee for too many years to recall, making a number of important contributions, and he is greatly missed. After ten years as treasurer Arlene Purdie took on implementation of the Xero accounting package no mean feat in itself and her inputs are missed. Taking on new technologies are the greatest challenge we face as we age and Arlene was undaunted in "giving it a go".

MINISTER'S POSTSCRIPT

Heard recently from a conversation in the Kerikeri community: "the Union church, where is that?" "Oh, you mean the place with the Car Boot Sales".

We do not lose heart, even though it could be very easy to. Our primary purpose as churches in both the Kerikeri and Whangaroa communities is to be the body of Christ where we live. Buildings are very valuable for carrying out that purpose but they can also cause us grief, and have us spending a lot of time agonising over issues. For yet another year this has been the reality for many of the hands-on workers in the parish. I feel for each of you who have continued to put heart and soul and mind into our stewardship of the Wesleydale Memorial Church in Kaeo and into our planning for a facility to use in conjunction with the community in Kerikeri.

For me, the Car Boot Sales are a beacon of hope. It may be a small thing in terms of the dollars they bring in, but this small beacon is bright and shining in terms of our profile and an emblem of our purpose. Thank you to those hands-on workers who are maintaining this mission to the community twice a month on the second and fourth Saturdays. Thank you also to those who help with the church stall and contribute saleable items to it for the second Saturday sale.

This year has seen me complete nine years as your minister. At the beginning of this calendar year I had my second Ministry Development Review, the process the Presbyterian Church has set in place to ensure ministers can retain their Certificate of Good Standing. This process, confidential to the minister but receiving input from as

many in the congregation as wished to meet with the reviewer the Rev Elizabeth Mansill, was timely as a lead up to the Churches Together Northland union church process to consider whether my ministry appointment would be extended beyond ten years. Alan Robinson has reported above on the Parish Council decision that resulted from this CTN visit.

My work as your minister continues to be that mix of parish and community which I have written of in previous annual reports. No doubt, for those who remember church and ministers in decades past, it is very different from what you have known and maybe what you would like. The level of community involvement is a function of where we need to be as a church. This is our future, being Christ-shaped people, doing Christ-like things, in the community. We draw strength and inspiration from our time together as church, on Sundays and on other occasions, so that we can be who were called to be among family and friends and in the wider community.

Yet this really isn't something new. When we read the gospels, we more often than not find Jesus out and about. He went to the synagogue to worship; he also went there to stir. That is, to raise questions and try to get his faith community back on task, bringing good news to the poor, sight to the blind, and freedom to those who are captive.
