### THESES REQUIREMENTS

The theses (4-8 pages) should be presented in Russian or English as a text file saved in Microsoft Word. The text must be submitted in Times New Roman font, 14 points, 1,5 -spaced on one side of the sheet of A4 (margins - 2 cm)., width alignment. **Images, graphs, tables,** etc. must be black-and-white. Inscription for them should be under each image in Times New Roman font; 12 pt. **Formulas** should be presented in Microsoft Equation 3.0 with the following parameters: standard index-14, large index-9, small index-7, large symbol-18, and small symbol-12.

The author's name and surname should be written in small letters on the first line, right alignment. City, country and institution - on the second line, right alignment. The title (centre justified) is printed in capital letters on the third line. Then goes the full text with the list of references in the end. The presentation of literature in the list should be in the APA style (see www.calstatela.edu/library/guides/3apa.pdf).

**Abstract** (30-60 words), **key words** (5-7 words), should be presented in English and Russian (if it's possible) and attached to the text.

Nonconforming manuscripts may be returned for technical revision prior to their review.
