## NEWS FROM THE CLUBHOUSE:

The Clubhouse at Carefree Club will be a very busy venue in the next few months as college and high school graduations begin. ## ***Pool Rules***

Circulated with your dues notice, but I want to point out two very important ones:

1. ***No diapers of any kind are allowed in the big pool!*** To accommodate you and your small children we have started to assemble a play area for small kids. So far we have a playhouse, a couple of desk, and some little people chairs. If you have any Playhouses or toys to donate or sale at a reasonable price, email the [pool@carefreeclub.org](mailto:pool@carefreeclub.org)
2. ***No Smoking ANYWHERE on Carefree property at anytime!*** Not even the parking lot. If you must smoke you must leave the grounds.

## ***Pool Passes***

In previous years we have been a little lax on pool passes. Last year it became a problem as more and more people from outside the neighborhood filtered in on a daily basis. Changes for this year:

1. ***No one will be allowed into the pool without the lot owner pass!*** Not much more needs to be said.....
2. ***NO GUEST PASSES will be accepted unless the LOT OWNER PASS is shown with it.*** Please don't give your guest passes away and expect that those people will be able to use them because they won't. The Lot Owner pass must accompany the guest pass or you won't be allowed in.
3. ***Lot owners bringing guests must present a pass to cover each guest or pay \$2 per guest.*** You cannot bring extra guest and sign them in on your lot pass. This will be monitored this year and addressed if caught. \$2 is a pretty cheap price to pay to swim. PLEASE respect our rules.

## ***Club Membership***

If one of your neighbors would like to join the club, here is the info:

1. Property must be located within Carefree North or South community and will be bound to the Club with a filing at the Johnson County Recorder's Office.
2. Pay the pool registration fee of \$600.00 (one-time fee)
3. Pay the annual maintenance assessment. The current assessment is \$228.00 (yearly)

## Pool Offerings

Please register a user name and password today!** If you are interested in any classes or lessons email [pool@CarefreeClub.org](mailto:pool@CarefreeClub.org) to register. Include the class you want in your email.

Offerings this year:

1. **CPR, FIRST AID, and LIFEGUARD In-services** will be offered throughout the summer. This is NOT for certification, but for education and will be free to Club members.
2. **NO ONE is permitted to give private swim lessons at Carefree Pool at anytime!** ALL private lessons must be scheduled through the Training Manager Holly Reed.
3. **MOM (or DAD) and Toddler Swim lessons** will be offered in the evenings weekly in the BABYPPOOL. Cost to members is FREE, if you would like to bring a mom and tot guest cost is \$2 per lesson per pair.
4. **Toddler up swim lessons in the big pool** will be offered in the evening in the big pool during open swim. These lessons will teach basic swim skills and water safety. Cost to members is FREE; cost per member Guest is \$2 per lesson per guest. This fee allows your guest to stay for open swim before and after class.
5. **Water Aerobics will be offered in the morning and evenings throughout the week.** We are looking into Water Zumba, water weights, and water walking.
6. **Early morning Adult Lap Swim.** For all you early birds we are opening M, T, TH, F at 6am – 7:30am. Lane Lines will be in. If you are brave, come dive in. FREE to members, \$2 per guest per day.
7. **BIRTHDAY PARTIES AT THE POOL!** This year we are offering a Birthday party package. Parties must have 10 or more guest. Parties include a private party guard, 1 ice cream treat, 1 water or Capri sun, games with small prizes, and entertainment. Cost is \$5 per child and can be scheduled anytime during open swim pool hours.
8. **Pool rentals** – Private pool rentals are available Sat Mornings from 8 to 11 am, and Evenings from 8 to Midnight. For evening rentals the pool will be open to the public until 10, but your guests may start arriving at 8pm. Pool rental will cost \$50 for a facility fee plus an hourly fee. Hourly fees of \$15.00/hr for the Manager and \$10.00/hr per lifeguard (two guards minimum) are required for a minimum hourly rate of \$35.00/hr. Hourly fees are paid in ½ hour increments and an additional 1/2 hour is added beyond the swimming period for cleanup and shutdown.
9. Read, Download, Sign and return the [Pool Rental Agreement](#) to the pool manager to secure your rental.

**The Undersigned Agrees to the following:**

1. To adhere to the "Procedures Governing Use of Carefree Club Pool" found below, the "Carefree Club Pool Rental Information" and "Carefree Club, Inc. Pool Rules".
2. To pay a rental fee of \$50.00, made out to Carefree Club, Inc., to the Facility Manager at the time of the reservation.
3. The rental reservation is not completed until the rental fee is received and the "Carefree Club Pool and Patio Rental Agreement" is signed by the Undersigned and Facility Manager, Pool Chairman or designee.
4. The minimum rental period is 2-1/2 hours with 2 hours for pool use and 1/2 hour for cleanup and shutdown.
5. To pay an hourly fee in 1/2 hour increments for lifeguards at a rate to be determined by the Pool Chairman. The number of lifeguards required will be determined by the Facility Manager. The hourly fees will be paid in full to the Facility Manager or their designee on the date of the rental. The rental fee will be refunded if notice of cancellation is received by the Facility Manager seven (7) days prior to the rental date, or in the event that inclement weather precludes use of the Pool on the rental date.
6. To examine the premises to be rented, and, after such examination, agrees to promptly notify the Facility Manager in the event the premises are not clean, neat, in a good state of repair, or if a defect exists that would render said premises unsafe for the purposes for which they were rented.
7. To be responsible for and to pay any costs of repairing any property maintained in the facility which is damaged as a result of their use, including the cost of a professional repair firm and any legal or other fees associated with attempts to collect repair costs.
8. To provide adult supervision at the pool for the full rental period for functions involving minors.
9. That possession or consumption of any illegal drugs by the Undersigned or their guests or alcoholic beverages by minors on CAREFREE CLUB, INC. property is strictly forbidden and will be cause for immediate termination of the rental period. All fees will be paid and no refunds of rental fees or hourly fees will be issued due to rental termination under this section.
10. To inform all guests of the rules and procedures governing the use of the rented premises, either verbally or by posting a copy of said governing rules in a conspicuous place.
11. To inform all guests that all personal property placed in or around the Pool and facilities, including, but not limited to motor vehicles parked on the premises, will be placed at the sole risk of the owners of such property.
12. Parking is at the risk of the motor vehicle driver or owner.
13. To pay a \$35.00 fee in addition to any bank or other fees for a returned check. To pay any legal or other fees associated with attempts to collect rental and hourly fees that are due.
14. To indemnify and hold harmless CAREFREE CLUB, INC. and each of its directors, officers, members, and agents from any liability arising out of or connected with UNDERSIGNED's use of said Pool or facilities.

**PROCEDURES GOVERNING USE OF THE CAREFREE CLUB POOL**

4. No child over eight (8) years of age is permitted to use the Junior Pool unless special permission is obtained from the lifeguard.
5. Lifeguards on duty will have complete authority over all activities at the Pool.
6. At the conclusion of the rental period, all trash is to be placed in the trash containers and patio/pool furniture is to be returned to the proper place.
