*****Registration Process for New Students****

- Complete one Registration Packet for each student attending.
- The person financially responsible for the tuition should select the payment option. If parents are paying separately, both must complete and sign a Payment Selection Form.
- \$150 registration fee (\$100 if paid on February 27, 2010)
- A completed FACTS agreement if applicable.
- Registration late fees are not assessed for new students.
- This registration fee is non-refundable and will not be deducted from tuition.

Registration Process for Returning Students

- 2009-2010 tuition account must be current before student can be registered.
- Complete one Registration Packet for each student attending.
- Submit \$150 Registration fee (\$100 if paid by or before March 1, 2010) to the Business Office along with all FACTS forms, if applicable. This registration fee is non-refundable and will not be deducted from tuition.
- Any Registration Packet or registration fee not received by March 19, 2010 will be assessed a \$150 re-enrollment fee, in addition to the \$150 registration fee totaling \$300, and could put your student on a space available wait list.
- The person financially responsible for the tuition should select the payment option. If parents are paying separately, both must complete and sign a Payment Selection Form.

Option # 1 FULL PAYMENT (Payments sent to CJ Business Office)

I agree to pay on or before July 1, 2010, the full payment of \$7,250 (parish rate) or \$9,250 (private rate). If such obligation is not satisfied by July 9, 2010, semi-annual payments will be implemented.

Option# 2 SEMI ANNUAL PAYMENTS (Payments sent to CJ Business Office)

I agree to pay the first half of the tuition amount \$3,625 (Parish rate) or \$4,625 (Private rate) on or before July 1, 2010 and the second half on or before December 10, 2010.

Option #3 QUARTERLY PAYMENTS (Financing with FACTS Tuition Management)

I agree to finance the four quarterly tuition payments of \$1,812.50 (parish) or \$2,312.50 (private) Payments are due July 2010, October 2010, January 2011 and April 2011. With this option, FACTS withdraws payments directly from your bank account. See FACTS instruction sheet for more details. To reduce quarterly payments, partial payments (a down payment) may be made in the CJ Business Office. This payment must be received by June 14, 2010, to be reflected on your first FACTS payment.

Option # 4 MONTHLY PAYMENTS (Financing with FACTS Tuition Management)

I agree to finance the tuition amount for a ten-month period, with the first payment being due in July and the last payment due in April. The interest rate will be 6.0%. Monthly payments before any partial payments or financial aid will be \$743.70 (parish) or \$948.85 (private).

With this option, FACTS withdraws payments <u>directly from your bank account. See FACTS instruction sheet for more details.</u> To reduce monthly payments and save money on interest charges, partial payments (a down payment) may be made in the CJ Business Office. This payment must be received by June 14, 2010, to be reflected on your first FACTS payment.

^{*}Note: Tuition only covers 69% of actual cost (88% for private students) per student. The remaining amount is subsidized by the generous support of our alumni, parents, and friends to the Annual Fund. To be eligible for the parish rate, families must be registered members of a Catholic parish.

FACTS TUITION MANAGEMENT OPTIONS #3 AND #4 INSTRUCTION SHEET FOR FACTS PAYMENTS

Chaminade Julienne has contracted with FACTS Tuition Management once again to handle our monthly and quarterly payments. With options #3 and #4, payments will be withdrawn directly from your bank account on the 5th or 20th of the month. This may be a checking or savings account, or you may use a bank credit card such as Visa, Master Card, and Discover.

Important enrollment fee information

In order for FACTS Tuition Management to work with our software, every student must be on a separate agreement. This means, siblings will not be able to share the same agreement. The cost for one agreement enrollment fee is \$41.00. Any additional agreement enrollment fee will be \$20.50 providing you use the same bank account for both agreements. FACTS will process the agreement and withdraw the \$41 when the plan is activated. Please be sure to have enough funds in your account by mid May to cover this fee so you will not incur additional service charges.

Not currently enrolled with FACTS at CJ

If you are not set up with FACTS at CJ, you have the option of filling out an agreement online via e-Cashier or an agreement will be mailed to you upon your request. To complete your agreement online go to the CJ's website click on the parent link then click on Business Office where you will find the link to e-Cashier. If you enroll in FACTS online, DO NOT complete a paper agreement.

In House Billing

Chaminade Julienne will provide In House Billing service for those families not wanting to have their tuition payments automatically withdrawn by FACTS; however there is a service charge associated with this service to offset the cost of manually having to process this information rather than it being electronically processed. The monthly service charge will be \$40 additional per month, and the quarter service charge will be \$50 per quarter.

1. What Is the Patron/Ad Drive?

It is a fundraiser that directly supports student activities including all athletic teams, drama, music, yearbook, and the school newspaper.

2. When Will the 2010-11 Patron/Ad Drive Take Place?

Students will receive their patron ad packets in July and are invited to sell their ads throughout the summer. More detailed information concerning raffles, contests, and timelines will come in that packet.

3. Does **Every Student Have to Sell Advertising Space?**

Yes. Each family, <u>every student</u> is responsible for selling ad space/patrons for a minimum of \$125 for school publications.

4. Why is the Patron/Ad Drive Mandatory?

To keep tuition costs down. Rather than adding \$125 or even more to each student's tuition, he/she has the opportunity to contact a local business for this expense. The Patron/Ad Drive raised over \$120,000 last year. It is the only required fundraiser of the year.

5. Why Does CJ Have a Patron/Ad Drive AND an Annual Fund?

Both of these vital programs directly benefit CJ on an annual basis, but in different ways. The Patron/Ad Drive supports student activities (drama, sports, music, yearbook, newspaper). Gifts to the Annual Fund are unrestricted, tax-deductible, and support <u>all</u> aspects of CJ's operating budget (spiritual development, academics, Christian service, athletics, arts, teacher salaries, etc). CJ hopes that parents will understand and support both programs to help bridge the over \$2,000 gap per student between tuition and actual cost.
