#### 2) Presentation by Joseph Becker “GIS: on the Critical Path of Next Generation 9-1-1”

- The slide showing the accuracy of call locations is about 2 years old, but it represented a large number of jurisdictions and reviews of all of them – all east of the Mississippi
- There does not seem to be much accuracy testing going on at this time. We should be doing more.
- ATT has sent out notices that they are pushing back implementation of the accuracy standard for 8 years
- What do we need to do with regard to address points – how many address points are required and where should they be?
- What is the nearest entry point? Driveway
- What will be implemented first and what ‘drivers’ are there for the data



## Next Generation 911 Work Group Meeting Notes for August 11, 2011

- We have the tools to push the data out now – ArcGIS for local government
- Help the CAD guys to stop trying to emulate GIS
- In 1995 – 75% of the PSAPs did not have mapping systems
- We should start going live with GIS in the operation centers
- There are some legal concerns
- Discussion about coordinated development of data sets – reduced costs, no edge matching problems, etc.
- Might want to inform people about the CAP awards for business planning that could be focused on this activity

### **3) Provide Status update on NSGIC's Next Generation 911 Brochure**

- Last week, NENA provide significant edits on the Working Smarter Together brochure
- We redrafted it and sent it out for final approval
- We are expecting approval and final edits very soon
