## What the Chamber does.....and doesn't do

We are often asked what exactly it is that the Chamber does. This is not an easy question to answer because of the diversity of our activities, as well as the wide variety of businesses and organizations that we represent. Hopefully, this will help to clarify some of our roles and responsibilities and will also spell out those things that we don't do.

- ⇒ **The Chamber is** the first stop for many visitors to our area. We provide assistance to individuals who are visiting, those who are thinking of relocating here, companies which would like to do business here, etc. We provide directions, brochures and maps, recommendations on where to stay or eat, souvenir items, things to do in our area, places to purchase items, where to go for more information, names of companies that produce certain types of products, and much, much more. And of course, whenever possible, we make referrals to our *member businesses*.
- ⇒ **The Chamber does** pay the majority of the expenses for the annual Christmas lighting program with some financial assistance from the City of St. Marys. **The Chamber does** put on the annual fireworks display by requesting donations from local companies and individuals and through fundraising activities. All money raised for fireworks is spent on fireworks.
- ⇒ **The Chamber is not** responsible for recruiting businesses for the downtown. However, **the Chamber does** work closely with both the Marienstadt Corporation and the City of St. Marys in all aspects of downtown revitalization.
- ⇒ **The Chamber does** provide numerous opportunities for our members to advertise their products and services. These include: Chamber Gift Certificates (redeemable only at current Chamber member businesses); mailing inserts (a great way to reach 300+ business people in our region); the Chamber Membership Directory (a full-color brochure, printed annually, listing our members and other pertinent information about the community); and our web site (all members are listed alphabetically and by category on the Chamber's Web Site).
- ⇒ **The Chamber does not** promote any individual company to the exclusion of others, but promotes our business community as a whole. **The Chamber does** provide assistance to existing and potential businesses. We are a Small Business Resource Center in cooperation with the Small Business Development Center at Clarion University. Coordination of grand opening and ground breaking ceremonies can also be provided.
- ⇒ **The Chamber does not** provide low-interest loans or grants to businesses or individuals. (For information on these types of funding, contact the St. Marys Area Economic Development Corporation).
- ⇒ **The Chamber does** monitor issues pending in the federal, state and local governments and inform our members when their input could be beneficial. We also sponsor periodic legislative forums so our members have the opportunity to speak to our legislators directly about their concerns. However, the **Chamber is not** a political entity. We do not endorse political candidates or their platforms.
- ⇒ **The Chamber does** provide information and assistance when requested to companies which are interested in locating here. However, **the Chamber does not** have any control over which companies come or do not come. The Chamber proudly supports the free enterprise system.
- ⇒ **The Chamber does** assist the local hospital in their recruitment efforts by providing community tours for physicians who express an interest in relocating here.
- ⇒ **The Chamber does** provide numerous opportunities for networking at a variety of events such as the Annual Dinner, Golf Outing, Women's Recognition Program, seminars, legislative meetings, etc.
- ⇒ **The Chamber is** funded by membership dues, project income, and sales of souvenir items and directories. **The Chamber does not** receive funding from any government agency.

# St. Marys Area Chamber of Commerce Member to Member Discount Program Special discounts, offers and promotions FOR Chamber members FROM Chamber members.

## ***What is it?***

A membership benefit program, offering discounts and special promotions on goods and services, provided by Chamber members to other members for a specified period.

## ***Who is eligible to participate?***

Any Chamber member in good standing may provide a Member Discount offer. The organization offering the discount sets the parameters of the offer. The discount is available to all the employees of the member firm.

## ***How does it work?***

Participating organizations complete a participation agreement, specifying the nature of the discount or special offer, and the length of time the offer is valid. (The minimum time duration is 6 months).

The Chamber keeps an up-to-date listing of all participating organizations on the Chamber web site. To take advantage of offers, members need only to present their membership card or some verification that they work for a Chamber member organization.
