May 31, 2011

To UU Partner Church Council Members:

Pursuant to Article III, Section 3.5 of the bylaws and the vote of the Executive Committee, notice is hereby given that the 2011 UUPCC Annual Meeting will be held on Saturday, June 25, 2010 at 1:15 p.m. at General Assembly in Charlotte, North Carolina for the transaction of the following business:

- 1. <u>To hear reports</u> of the officers and of such committees as may report to the meeting and to take such action thereon as may seem appropriate
- 2. <u>To elect members</u> to the Board of Directors and the Nominating Committee
- 3. To see if the members will vote to amend the bylaws
- 4. To transact any other business that may properly come before the meeting

NOTE: Article IV Meeting of the Membership, Section 4.4 of the bylaws reads: "Each individual member is entitled to one (1) vote. Each set of persons who have joined as a family membership is entitled to a total of one (1) vote. Institutional members are entitled to designate three (3) voting members who shall have one (1) vote each." Notice of this meeting is being sent to all individual and institutional members in good standing as of March 31, 2011.

<u>Board of Directors</u>: The Board of Directors of the Partner Church Council is composed of 12 members. The members of the Board of Directors shall be elected for three (3)-year terms. Four (4) members shall be elected each year at the Annual Meeting of the UUPCC. A person may serve a maximum of three (3) consecutive terms, except that a person appointed to fill a vacancy may serve no more than ten (10) consecutive years. Terms shall begin at the conclusion of the Annual Meeting.

<u>Nominating Committee</u>: The nominating committee will be composed of three members. The members of the nominating committee will be elected at the annual meeting of the Council for a staggered three-year term.

For three-year terms until 2014 (Four positions available)

The Rev. Roger Bertschausen, Appleton WI

Roger Bertschausen is the Senior Minister of the Fox Valley Unitarian Universalist Fellowship in Appleton, WI, a congregation he has served since 1990. He is a graduate of Bowdoin College and the University of Chicago Divinity School. Roger's congregation has been the partner church of the Unitarian church in Deva, Transylvania since 1999. Roger visited Deva in 2000, and shared in the joyous dedication of the new church in Deva in 2008. Roger's congregation has recently entered into a second partnership with the church in Banaybanay, the Philippines. Roger has been a UUPCC Board member since 2008.

George Davenport, Tulsa OK

George Davenport has been a UUPCC Board member for the past six years, and has served as its Treasurer for the past four years. A geologist, George resides in Tulsa, where he is an active member of the All Souls Unitarian Church which is partnered with Énlaka in Transylvania and Kampala, Uganda. He has traveled to Romania on several occasions, including once with 45 members of the All Souls' Youth Choir, and has also visited Uganda.

Cathy Perry, Bellevue WA

Cathy Perry is an active member of Bellevue, Washington's East Shore Unitarian Church's Partner Church Ministry team which enjoys three vibrant partnerships in Transylvania and the Khasi Hills and is currently chair of the Transylvania team. Cathy has made many visits to overseas partners and has participated in three Community Capacity Building Workshops. She serves as a networker for the Khasi Hills and promotes partnership activities in the Pacific Northwest District. Cathy has been a UUPCC Board member since 2009 when she was appointed to fill a vacancy.

Richard Van Duizend, Falls Church VA

Richard Van Duizend is a Court Management Consultant and has pursued his work throughout the United States and its territories, and internationally in countries such as Bangladesh, Canada, Egypt, Lebanon, and Nigeria. Richard has been a member of the Partner Church Circle of the UU Congregation of Fairfax (VA) for 20 years, and has visited both its Transylvanian partner, Szentgerice, and its partner in the Khasi Hills, Puriang. In case of a vacancy on the Board of Directors, the remaining members of the Board of Directors may appoint a replacement to fill the unexpired term. Terms shall begin at the conclusion of the Annual Meeting.

2011 LOUIS C. CORNISH "LIVING THE MISSION" AWARD The Rev. Gretchen Thomas

The Board of Directors of the UU Partner Church Council is pleased to announce that at its March meeting the Rev. Gretchen Thomas of Fitzroy Vic, Australia was named the recipient of the Louis C. Cornish Living the Mission Award for 2011. In so doing, the Board recognized Gretchen's outstanding contributions, both past and ongoing, to the Partner Church Council and to the partner church movement. In nominating the Rev. Thomas, the Rev. David Keyes, former President of the Partner Church Council Executive Committee, wrote, "She was a stalwart from the earliest days of the partner church movement. In San Jose and Homoródszentmárton she and József [Kászoni] created a model of partnership that inspired many, many of us. The Francis David Youth House was one of the fruits of that partnership, as was József's evangelism for partnership to various tours in North America. Next, Gretchen created the Canadian partnerships with Hungary. All the while, she served on the PCC Exec. where she brought a level head and the perspective of a minister of religious education." Gretchen designed the networkers system of the UUPCC, served on the partner matching committee and continues to serve on the Religious Education committee. The Rev. Thomas was one of the first North American UUs to visit Transylvania following the 1989 revolution which brought down the Romanian dictatorship of Nicolae Ceausescu. With the recent publication of the Rev. Thomas's inspiring new book, Walking in Others' Shoes, and a recent article in the UU World magazine, this recognition of Gretchen Thomas's contributions to partnership seems timely, if not long overdue.



2011 STEWARD OF PARTNERSHIP AWARDS

Bylaw Amendment, Proposed May 13, 2011 To be voted on at the UUPCC Annual Meeting, June 25, 2011

Proposed Changes to UU Partner Church Council Bylaws, June 2011 **ARTICLE 4 – Meeting of the Membership of the UUPCC**

[Strike-through indicates proposed deletion; <u>Underline</u> indicates proposed addition.]

PROPOSED AMENDMENT:

4.1 Meetings. The members of the UUPCC shall meet at least annually on a date determined by the Board of Directors. during the UUA General Assembly (Annual Meeting) and at such other times as may be determined Special Meetings of the members may be called by the Board of Directors or at the request of at least 25 UUPCC members.

Proposed change: In sentence 1 section 4.1, delete the reference to General Assembly, after the word "annually" and insert the words "on a date determined by the Board of Directors."

In sentence two add the word "Special" at the beginning of the sentence.

Explanation of proposed change: Should General Assembly not happen annually in the future, it is important for the Bylaws to allow the flexibility to meet at some other place and time. The Board is not considering any changes at this time because GA is scheduled for the next 4 years.

Adding the word "special" clarifies that members may call a special meeting by request.

PROPOSED ADDITION - NEW SECTION 4.6

4.6 Telephonic Participation. Members may participate telephonically in any meetings of members of the UUPCC, but only if the notice of the meeting specifically permits such participation and provides instructions as to how members may do so. "Telephonic participation" means participation by telephone conference call or similar communications equipment so that all persons participating in the meeting can hear each other at the same time. Participation by that method constitutes presence in person at the meeting.

Explanation of proposed addition: This will allow participation at a meeting of the membership. Right now, only actual physical presence is allowed.

Unitarian Universalist Partner Church Council VISION AND MISSION STATEMEN'T June 2010

Vision: We envision a worldwide Unitarian and Unitarian Universalist community that promotes peace, justice, and liberty for all, supported by partnerships that are integral to congregational life.

Mission: The mission of the Unitarian Universalist Partner Council is to foster and support partner relationships between UU congregations and individuals in the United States and Canada with Unitarian and Unitarian Universalist congregations, orphanages, schools and students in all other countries where partnering is sought and welcomed. These will be mutually beneficial, responsibly sustained, and linked by joint and mutual covenants.

We will:

BE a bridge that connects congregations around the world;

REACH across boundaries to collaborate with old and new partners;

CREATE transformational opportunities for pilgrimage and hospitality, for learning and for service;

CHALLENGE ourselves theologically and open ourselves to changed values and behaviors;

ESTABLISH global community as a common commitment of liberal religion;

INITIATE partnerships that promote global friendships, international awareness, human rights, and a better world; and SUSTAIN this global vision, enlarging and renewing it as new occasions teach new duties.

Annual Chair's Report - 2011 PRESENT, PAST, AND FUTURE

It is an honor to submit to you my second report as Chair of your Board of Directors. There is much to tell you about our vibrant partnership movement. In the next few pages, I would like to address the present status of our movement, the celebration of our past, and outline the steps we are taking for the future.

PRESENT: There are currently 160 North American UU churches with congregational partners in 9 nations – Transylvania, Hungary, the Czech Republic, India, Hong Kong, the Philippines, Burundi, Uganda, and Nigeria. Four new congregational partnerships have been formed between Lewes DE and Tordatur, Romania, Mission Viejo CA and Madan Laban, India, Cambridge MA and Bordos, Romania and Appleton WI and Banaybanay Philippines. Unfortunately, two others may be in the process of dissolving. We are working closely with ICUU to find partners for newly emerging congregations in Kenya. These partnerships will be mentor/relationships initially as the congregations there develop. We are hopeful that partnership bonds may be formed in the coming years with congregations in other nations as well – Indonesia, Mexico – as well as additional partnerships with the many congregations in Transylvania, India, and the Philippines seeking to partner. We have more requests than we have congregations here wanting to partner, so if you know of a congregation in the US that may be interested in a congregational partnership, please let me or the UUPCC's Executive Director, Cathy Cordes, know.

We also initiated a new form of partnership this year – congregational sponsorship of classes at the New Life School founded by the UU Church of Uganda. The congregations pledge to support a class for the duration of its education at the school. The congregations pledge to send approximately \$2400 each year. I am very pleased to tell you that nine congregations – including six who have not been part of the partnership program previously have pledged support this year. We will need more congregational sponsors in the future, so if your congregation or another you are aware of may be interested, again, please let us know.

The other Path to Partnership Programs also are moving forward. A total of 58 children are being supported by scholarships. Workshops to train local CCB facilitators took place in the Khasi Hills and the Philippines this year and very successful CCB processes were conducted in villages in both regions by the newly trained facilitators.

PAST: On July 22 – 24, I had the privilege of participating in a celebration in Kolosvar, commemorating 20 years of the modern partnership movement. It was a joint celebration discussing the meaning of partnership on both sides of Atlantic that included many others from the US including former UUA President Rev. William Schulz; UUA Ambassador to the Transylvanian Unitarian Church and former UUPCC Board Member, Rev. Harold Babcock; Cornish Award winners Larry Coburn and Dr. Judit Gellérd; former UUPCC Board Members Linda Lu Burciaga and Barbara K. Beach, Executive Director Cathy Cordes, Stewards of Partnership Awardees Anne Greenwood and Bob Tripp, the UUSF Choir, and several other ministers and lay members

The celebration had a bit of everything – retelling of the history, recounting of successes and slights, expressions of hopes and philosophical musings, old friendships renewed and new ones kindled, exchanges of gifts, convivial toasts, exquisite musical performances, and solemn prayers Most important were the stories -- stories of the transformational power of relationships between people, congregations, and communities; stories of health clinics built, of children educated, of churches repaired, of meals shared, of babies loved, of tragedies mourned and much, much more. As always, our hosts and the hospitality were wonderful.

Reflecting on all these words, hugs, and smiles and my own 19-year journey in partnership, I have come to recognize that:

1. The "Save Transylvania" era is over. Transylvania and Transylvanians are no longer isolated. There are still problems and life for many remains hard, but there is also a greater sense of assurance among Transylvanian church leaders, a determination and ability to do things for themselves, and the hope that in the future, there will be partnerships between Transylvanian Unitarian congregations and U*U congregations in Africa, Asia, and Latin America, as well as North America. This does not mean that the era of partnership is over. Quite the contrary, the

desire and importance of direct personal relationships between Transylvanian and North American congregations is as strong or stronger than ever.

2. There remains too little understanding of the great gifts North American UUs have received from partnership over these 20 years. We too were isolated – cut off from our spiritual roots; our history; a recognition that ours is a faith not just of the head, but of the heart and the belly as well; and an understanding that Unitarian-Universalism is not just a religion for well-educated, well-off, Americans of European ancestry, but can provide strength, hope, and sustenance to people of all educational and economic levels throughout the world. These great gifts may be intangible, but they are hardly inconsequential.

FUTURE: Your UUPCC Board meets in person twice each year in addition to monthly teleconferences. The main focus of our in-person meeting in February was setting goals for the future and prioritizing strategies for meeting those goals. In order to choose among the many good ways in which we could invest our energy and resources, we used the "pair-wise ranking" process, one of the tools developed for Community Capacity Building methodology. After refining a proposed list of priorities, the Board compared each possible priority to each of the other priorities and discussed which should be addressed first. Decisions regarding each pair were made through consensus rather than formal voting. Quite frankly, this was not easy. Often we had to choose which of two very important and beneficial items is the most important. Margot Fleischman, our Staff Assistant of many talents, proved herself a superb facilitator by asking questions at key moments to help us find a path.

We set four goals for this year:

- * Retaining and revitalizing current congregational partnerships
- Growing the number of individual and congregational partnerships
- ❖ Increasing the number of individual and institutional members of the UUPCC, and
- ❖ Addressing key governance, administrative, and policy issues

Many of the strategies we decided upon are intended to achieve two or more of the first three goals. These include:

- Enhancing interest and participation in partner church activities by using social networking. There is now a UUPCC Facebook page with a growing membership and we be creating a template that partners can use to exchange messages, photos, videos, etc. more quickly and easily. In addition, we will be updating our website to make it even more informative.
- Preparing some exciting new RE materials for North American congregations explaining what a Sunday morning is like for children in Transylvania, India, The Philippines, and elsewhere;
- Exploring ways to increase the opportunities for those studying for the UU ministry to experience our dynamic faith as it is practiced in other nations, and share what they are learning with their colleagues here and there;
- Building knowledge about Community Capacity among partners;
- Establishing the new program of partnership with classes at the New Life School operated by the UU congregation in Kampala, Uganda; and,
- Continuing to work collaborative with other UU organizations that operate internationally.

To address the administrative goal, the governance, administrative, and policy priorities of the UUPCC Travel Program are being refined to address concerns expressed by some of our hosts in Transylvania, to reflect that extension of the travel program to other regions, and to ensure that pilgrimages are aligned with spiritual, relationship, and communication goals of partnership. We also agreed to prepare proposed changes in our by-laws for consideration by you at the Annual Meeting. One change will provide greater flexibility about when the Annual Meeting can be held to prepare for the possibility that General Assembly will becomes a biennial rather than an annual event. The second change will permit participation in the future via telephone when the technology to do so is available and cost effective, so that discussion and voting is not limited only to those able to attend in person. Finally, we will be working to further ensure financial accountability when funds are transferred. Thank you for the privilege of allowing me to serve on your Board.

UUPCC Travel Committee Report

A top priority at the February 2011 UUPCC Board retreat was to refine and align our travel program. In an effort already underway, this committee had taken new shape in 2010 with a new charge:

Envisioning the services and providing strategic guidance to UUPCC's Travel Service¹ as it works to coordinate travel that is:

- Mutually beneficial for both the visitors and the visited
- Delivered in an enjoyable and sustainable way

The committee work emphasizes:

- Creating opportunity for meaningful person-to-person or congregation-to-congregation connections
- Ensuring that clear expectations are set and met
- Ensuring that clear communication is used to and from all parties

The goal of delivering the opportunity for transformational experiences is the driving force. Measurement against this goal will include follow up surveys of both partners by the committee.

A major initiative of the committee is to clarify and codify policies, processes and guidelines for our pilgrimages. Most pilgrims that use the travel service are North Americans going to Transylvania; but trips to the Khasi Hills of India and to the Philippines are more and more popular. Examples of our recent work:

<u>Transylvanian Homestay Travel Rate Sheet</u>: We reviewed rates. Then revised them based on competitive costs, and then published a rate sheet, shared with the partner ministers:

- ° \$15 USD per night/per person bed and breakfast. \$8 USD per person for each additional in village meal lunch or dinner
- Senior Interpreter/Guide \$50/day and Youth Interpreter/Guide \$25/day
- ° For a congregation trip, we will also offer a Partner Minister Honorarium of \$100 for your assistance facilitating the village program and housing arrangements.
- ° The money will be paid in full in \$USD to the partner minister for distribution.
- 1. <u>Partner Minister Participation</u>: As of December 2010, we are phasing in a new policy in Transylvania. For all new pilgrimage itineraries being developed and budgeted, it is our policy to invite the Partner Minister to join Pilgrimages for part of the trip prior to and/or after partner congregation stays. Any cost will be built into the per traveler cost of the trip. This will allow the traveling group to:
 - Oet to know their partner minister better and vice versa

¹ The UUPCC Travel Service offers "one-way" pilgrimages (151 pilgrims traveled in 2010 with about the same number planning trips for 2011) for members of North American congregations to visit partners overseas. It provides: 1) a pilgrimage preparation curriculum to help maximize the potential for real partnership connections to be made by educating and orienting our travelers to the religious roots and approaches of their destinations 2) pre-trip coordination and communication for interested individuals and congregations considering trips, including itinerary development support,3) travel arrangements and reservations for the trip and communications about partner homestays, and 4) marketing and administrative support and financial management of trip costs and expenses. Pilgrimage itineraries are developed to meet travelers' timing, needs and desires, and are coordinated with partner ministers in Transylvania. Almost all trips include home stays in partner congregations or stays in close proximity for India and the Philippines. And almost all trips start and/or end in Budapest or Bucharest, Manila and Delhi so as to help groups most easily coordinate their international flights. It should also be noted that a good number of individual pilgrims travel independently.

- ° To best prepare the group for their partner congregation stay
- ° To have the voice of their partner minister on their pilgrimage tour to help provide religious history and context
- 2. <u>Van Driver Form:</u> Vans are rented for use by small pilgrimage groups. We instituted a new form in early May to easily monitor rented van use and clarify compensation policies and requirements for van drivers. This is being implemented in Transylvania now and will be extended to other geographies.
- 3. <u>Criteria for Travel Grants</u>: Another effort was to clarify and publish the criteria used to support the travel grants available from the UUPCC. In the first round of awards for 2011, \$2,500 in total was given out in support of 8 applications, with the majority of the funds again supporting travel to North American from representatives of overseas partners. Priority is now placed on:
 - ° Requests for travel from overseas partners to the North American partners.
 - First visits or very infrequent visits between congregations, or first visits one-way.
 - ° Visits that coincide with a special event. (Example: church dedication, General Assembly, Community Capacity Building workshop, installation of minister, etc.)
 - Trips that are organized to strengthen the congregational partnership. (How much time will the person/s spend with the partner congregation? Special religious services planned during the visit?)
 - ° First time travel grants for this partnership.
- 4. Financial Overview: In February 2011, we provided a financial overview to the Transylvania Unitarian Church leadership that breaks out costs and compensation for those involved in the pilgrimage program there over the last 3 years. Approximately 30% of travel costs are paid to Unitarians in Transylvania for congregational stays, and Unitarian Guest House stays. This also includes a \$30/pilgrim impact fee that is paid to the Transylvanian Unitarian Church. The balance goes for hotel, restaurant, transportation costs and staff compensation. Costs and expenses vary significantly year to year based on the number of pilgrims and the size of the trips. Most trips start and/or end in Budapest or Bucharest and include a stay in the headquarters city of Kolozsvar, and many include stops in Torda and Deva, so the significantly higher cost of city hotels and restaurants must be taken into account. Other historically interesting locations nearby, like Segesvar, are often included in the itineraries. Transportation is a very important cost factor as gas is much more expensive in Europe than in the U.S.

The UUPCC's travel coordinators are paid a monthly salary, but the majority of their compensation comes from per pilgrim commissions and per day trip guiding and translation fees. Two items of note: 1) Choir trips are larger and involve more trip coordination help and more hotel nights and 2) Each pilgrim separately organizes and pays for their own airfare. Each travel season, \$15,000 is budgeted towards the UUPCC operating costs to cover the travel coordinator salaries mention above as well as marketing and administrative support and expenses.

5. Measurement Surveys: We conducted (and plan to continue to conduct and expand) two on-line surveys assessing the trips provided by the UUPCC Travel Service: We surveyed North American pilgrims to Transylvania and the ministers of their partner congregations. We wanted to make sure that we were 1) Providing opportunities for personal connections and relationships among Unitarians and Unitarian/ Universalists and 2) That communications and expectations are clear for both pilgrims and their hosts.

Among pilgrims:

- ° 75% were extremely satisfied overall with the pilgrimage, with the remaining 25% quite satisfied. Similar percentages resulted for the satisfaction with the value of the pilgrimage.
- All felt that the information and itinerary they received before the trip were very good or excellent.
- 95+% felt that their visit with their partner congregation was both meaningful and enjoyable. A similar high percentage enjoyed the families they stayed with, the food, and the activities there.
- 90+% rated the tour leaders and tour guides as outstanding with 96% saying that the organized touring was either very good (55%) or outstanding (41%).
 - "We were lucky to have such knowledgeable people traveling with us and guiding us along the way.
- "This trip was deeply moving in a thousand ways. I loved getting to know and love the people in our partner village, and to learn about their life. I also treasured the chance to understand the Unitarian side of our history and visit places of historical

significance...Our leaders were fabulous and the group was mellow and enjoyable. I wouldn't change a thing about our experience. Thank you for making this life changing experience possible. I hope many more people have the chance to make a pilgrimage like this. It is so important that the world knows about Transylvanian Unitarians. I feel so lucky to have been a part of this adventure."

2010 North American Pilgrim Quote

Among partner ministers:

- All Transylvanian ministers who responded noted that their expectations about their partner's stays were very clear and that they knew just what to expect about payments, transportation, and dates:
- "The whole visit was great, we've had a wonderful time together, and as a first meeting, I would say it was very useful and pleasant."
- "We were able to create moments we all fully participated in: joint meetings, sharing our ideas and thoughts, activities involving both sides."
- "It was very good that I had nothing to do with the financial part of the trip."
- "John Dale was with us, helping on translation and helping with any other problems. In this way the American visitors could get a clearer view of how our church is working, because they could get something seen with an American eye. This was a great help."
- "Everything went well. I had not much to do about the whole visit. I have previous experiences when I tried to make all the arrangements for the visitors by myself, and I know how hard and difficult it was."
- "We are living in a country where almost everything is done in a so called "Balkanic" or "Romanian" way. I am happy that the UU pilgrimages are done in an "American way"."

The one change that some of the Pilgrims and Transylvanian partner ministers would make about their partner stay was to extend the duration of the visit to the partner congregation. We are working toward this goal and future itineraries already reflect this.

I think a group has to spend at least 2-3 days, not including the arrival and leaving day, to have time to start personal relationships and to know each other, and to have time for fun and to visit the old friends and the village.

This is a journey we are all on. It is an important journey. And travel is the most important way to make personal and congregational connections with our partners. This committee will continue to work to support alignment and ongoing refinement of this travel. We will continue to seek feedback and to clarify our efforts in this regard.

UUPCC Communications Committee

The Partner church Program's lively exchange of questions, ideas, and success stories from around the world is made possible by a network of communication that invites all our members—not just the leadership and staff—to participate. Rather than depending on "official" content to keep our program running, we are enriched by an enormous web of wise and creative people, all of whom are committed to nurturing partnerships worldwide.

We're pleased to announce that we've added one more strand to our web of communication—the Partner Church Council Facebook page. Now you have one more way to share your experiences and excitement with other leaders of Partner church programs around the globe.

If you're already a Facebook user, then you know how easy it is to share quick messages and resources online—just log into Facebook, begin typing "Unitarian Universalist Partner Church Council" into the search field at the top of the page, and you should quickly see the link to the Partner church Facebook page appear. When you arrive at our page, just click the "Like" button at the top of the page, and you're ready to share the news about partnerships around the world—add your own stories, photos, links, and even videos! you'll see how Facebook gives us the opportunity to liven up our partner connections. (NOTE: You can find and view the UUPCC Facebook page but, if you don't have a Facebook page, you won't be able to post comments.)

If you're not a Facebook user and you aren't sure whether you'd like to sign up, here's a brief introduction to how connecting through Facebook can add a new dimension to our network of international partnerships:

Facebook is like a lively bulletin board with material that is always changing. you and those whom you have accepted on your Friends list can share public and private updates, notes, pictures, and videos, so the content is much more diverse and dynamic than a newsletter or an e-mail list like our Pcc-chat.

The Facebook format provides you with two basic views: your **Wall** and your **News Feed**. Your **Wall** shows items that are specifically yours: messages, updates, or other items that you have sent or that others have sent to you. Your **News Feed** shows the messages, updates, and other items posted by all of the people who are on your Friends list; because this can result in a lot of activity, you can also limit this view to **Most Recent**.

One of the concerns voiced by our members who are not already using Facebook is the issue of privacy, and we take this concern very seriously. Once you're set up as a member of Facebook, it's worth a few minutes to make sure that your settings are providing a high degree of protection, which you can always adjust as you become more familiar with them. Facebook's default setting is completely public, so you need to think of your participation as *visible to everyone* unless you explicitly set it otherwise. To adjust your settings, click on "Account" at the upper right of your Facebook page, and select "Privacy Settings" from the drop-down menu. This Privacy Settings page is a good one to explore, and we recommend that you set your controls to the most conservative settings until you feel more confident with your new network. For example, under "Sharing on Facebook," you're likely to see that the level of privacy is set to "Everyone," the most public setting; changing that to "Friends Only" will restrict your communications to the circle of people you have approved as Friends.

Another important item on the "Account" drop-down menu at the top right of your page is "Account Settings." One of the tabs you should see on that screen is "Notifications," which controls when Facebook sends you an e-mail to notify you of activity on your page. I personally uncheck essentially all of those check-boxes on that page, because my email's inbox would be filled with messages in no time! Again, these settings are worth experimenting with, but I suggest that you keep your controls restrictive at the beginning, and adjust them as necessary when you feel more comfortable. One of the things we'd most like to encourage the users of our Facebook page to do is to post activities, success stories, pictures, and videos of their Partner church relationship and committee.

The UUPCC Facebook page is a new feature that we're all learning how to use together, so we encourage you to experiment along with us. as we like to say in the Partner Church Council, "the most radical thing we can do is to introduce people to one another," and our new Facebook page offers one more exciting way to nurture these connections!
