During the summer storage period (1st Mar to 31st Oct) access to the caravan bay for caravan collections is between the hours of 9am and 8pm and for returns between the hours of 9am and 6pm (Sundays 4pm). Minimum 24 hours notice required. Access at any other time by prior arrangement only

During the winter storage period (1st Nov to 29th Feb) notification must be given by the 1st October if access is required, if no request is received we cannot guarantee your van will be accessible. Minimum of 7 days notice required and charge of £20 (each way) payable in advance.

All gas bottles to be disconnected and no other noxious, dangerous, hazardous or explosive goods are permitted.

Only Westbrook Farm Caravan Storage authorised staff are allowed access to the storage compound.

Westbrook Farm Caravan Storage and its staff are not held liable for any damage to any caravan or its contents as a result of towing or movement of the caravan unless to the proven negligence of Westbrook Farm Caravan Storage or its authorised staff. Any suspected damage must be reported on immediate arrival at Westbrook Farm.

All caravans must be insured and kept insured during the period of storage (a copy of the insurance document may be asked for) **All caravans are left at your own risk and we are not liable for any damage or theft.**

All caravans must be kept in good towable condition. To be eligible for our towing service proof of roadworthy condition must be provided, i.e. valid service history documentation or caravan road worthy test issued within the last 12 months. If a caravan is deemed unsafe to tow the owner will be notified and the towing service will be temporarily withdrawn until any necessary repairs have been made.

Caravans must not be inhabited during the storage period. No trading is permitted from the site, and the caravan must not be offered or advertised for sale while on site. No major repairs to be carried out on site. Minor repairs by an authorised agent may be carried out with the permission of the proprietor.

In the event of the storage fee being overdue the proprietor will retain possession of the caravan until arrears are settled in full or are otherwise discharged. The proprietor undertakes to notify the owner of the possession by recorded delivery. **We operate a 3 month repossession policy on outstanding accounts and monthly £10 interest charge on all late payments and outstanding accounts.**

In the event of negative response to possession, legal action will be taken to sell the caravan via **The Torts Interference with Goods Act 1977**. The outstanding arrears will be deducted from the proceeds of the sale, as will any costs incurred. The remaining balance will be retained to await collection. The proprietor will seek to obtain the best price available based on current market values.

The proprietor excludes all liability caused by Vermin Infestation, a recognised vermin control regime is in place and is monitored regularly.

**No refund of fees will be made in the event of early departure.**

In the performance of this agreement the proprietor will at all times act with due diligence in providing secure storage.

The proprietor excludes all liability for loss or damage by whatever cause where means employed are in excess of due diligence.

Any change to the details provided by the plot holder in this agreement to be notified to the proprietor without undue delay.

Periodic checks may be made on the identity of all the caravans stored on site.

**The provision of a plot in the storage compound is deemed acceptance of these terms and conditions.**
