NOTICE TO BIDDERS: Amend the Project Manuals and Drawings to the above referenced project as follows:

GENERAL

ITEM NO. 1 - General Questions

- A. **Question:** Must contractors provide a bid bond for each facility site or one bid bond for the project as a whole? **Answer:** Contractors can provide one bid bond for the project as a whole.
- B. **Question:** Is there a concrete pavement detail? **Answer:** Utilize the slab thickness and reinforcing called out in the City of Raymore Drawing St-9 for concrete pavement details.
- C. **Question:** The bid quantity for linear feet of curb and gutter shown on Sheet C1.1 for Creekmoor Elementary calls out "verify". What is the bid quantity for linear feet of curb and gutter at Creekmoor Elementary? **Answer:** Zero (0) linear feet.
- D. **Question:** It appears from the alternate mix design as described in Addendum No. 1 that a Type 3 pavement with recycled asphalt meets the requirements. **Answer:** Yes, APWA Type 3 mix with recycled asphalt can be used as long as it passes the AASHTO T 283 test at the time of design (minimum 75% retained tensile strength). The AASHTO T 283 test results shall be submitted in order to get mix design approval.

It is agreed that no person or company other than the firm listed below or as otherwise indicated has any interest whatsoever in this Bid or the contract that may be entered into as a result of this Bid, and that in all respects the Bid is legal and firm, submitted in good faith without collusion or fraud.

It is agreed that the undersigned has complied or will comply with all requirements of local, state, and national laws, and that no legal requirements have been or will be violated in making or accepting this Bid.

The undersigned has included in all quoted prices the cost for all applicable federal, state, and local taxes to items subject to said taxes.

NOTICE OF ACCEPTANCE

If written notice of acceptance of this Bid is mailed, telegraphed, or delivered to the undersigned within sixty (60) days after the date of opening of bids, the undersigned will then execute the formal Contract and deliver, within ten (10) days of notification, all bonds and certificates of insurance as required by the Specifications.

In the case the undersigned fails or neglects to execute the Contract or deliver required bonds and insurances within ten (10) days of notification, all bonds and certificates of insurance as required by the Specifications, the undersigned will be considered as having abandoned the Contract and shall forfeit bid security and status as a low bidder.

BID WITHDRAWAL

This Bid may be withdrawn at any time prior to the scheduled time for the opening of Bids or any valid postponement thereof.
