Helpful information:

Consumers in respect of whom a prescribed activity is undertaken can create Victorian energy efficiency certificates (VEECs) under the *Victorian Energy Efficiency Target Act 2007*. One VEEC represents one tonne of carbon dioxide equivalent (CO₂-e) to be reduced by the prescribed activity undertaken by the consumer. Consumers are able to assign their right to create VEECs to an accredited person, in this case Ecofeet, who is working with Reltech to deliver a rebate. In assigning their right to an accredited person, the accredited person will be entitled to create and own the certificates in respect of the prescribed activity undertaken by the consumer. In return, the accredited person should provide consumers with an identifiable benefit for the assignation, such as a price reduction on a product, free installation or a cash-back arrangement. Consumers should be aware that it is their responsibility to negotiate satisfactory terms with the accredited person in return for assigning their right to create VEECs.

Terms and conditions:

- To be eligible a high efficiency pool pump must be installed at a residential premise in Victoria by a suitably qualified business. The pump may be installed as a replacement or for a new swimming pool or spa.
- Ecofeet, the provider of this rebate, reserves the right to establish eligibility of a rebate claim.
- Rebate prices may fluctuate, as the end product, Victorian energy efficiency certificates are subject to price fluctuations.
- Forms must be received no later than April 31st of the year following installation of a high efficiency pool pump.
- Rebate offer expires January 1st 2020.
