Accountability Is Key for Nonprofits

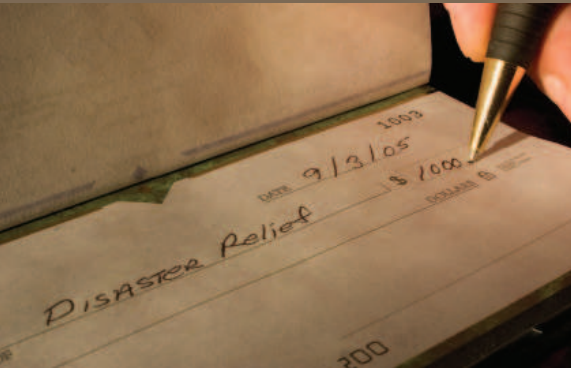
With the number of audits involving nonprofits rising year after year, it has become clear that your organization, its structure, and its internal controls must be able to withstand the scrutiny of the IRS. The current economy notwithstanding, nonprofit numbers and revenue levels are increasing, with over \$300 billion moving through nonprofits annually. This number is resulting in increased scrutiny from the IRS and other governmental agencies.

With the increased attention from the IRS, it is critical that your nonprofit be ready to withstand a very close review. The required annual filing with the IRS, Form 990, brings with it a myriad of challenges that your organization is required to meet. Form 990 looks at just about every aspect of your organization's operation, from larger issues like compensation approaches and board formation to more detailed items like reporting and record retention. So just as Sarbanes-Oxley (SOX) created a significant amount of pressure for standard for-profit corporations, so too the pressure is mounting for nonprofits.

Our firm understands that there is a lot at stake. In this case, the IRS has levied penalties and fines for organizations failing to comply. But even more important is the potential risk of a nonprofit damaging its reputation among the donor community or having the distraction of a scandal when it should be focused on its mission. On the surface, nonprofit compliance is about accountability and transparency, but in the end it comes back to being able to focus on your mission and the people you strive to serve.

Circular A-133 and Governmental auditing standards, sometimes referred to as the "Yellow Book," presents so many compliance areas needing attention that the task is too great for most sole practitioners or even small CPA firms to properly address.

What is really at risk?
