## IMPLEMENTATION PLAN BETWEEN

### PARTNER INSTITUTION

In support of the Agreement of Friendship and Cooperation between the Partner Institution and Indiana University, under which our two institutions plan to cooperate in order to advance our mutual interests, the following activities are agreed upon during the 2007-2008 academic year.

Each institution may select and nominate one graduate student to visit the partner university as an exchangee. The length of each exchange visit will be one academic semester. Each host institution will determine whether recommended students are acceptable.

Dossiers, including a brief biographical account, certificate of language competency, and a statement of purpose for the exchange period at the host university, must be received six months prior to participation to allow time for visas and documentation. If nominees expect to earn degree credits at the host institution, each must complete all relevant application forms and be acceptable to the host university degree program.

Exchangees may be of any branch of learning, but with consideration of the following preferences:

Each host university will provide exchangees with board, lodging, tuition, and health insurance, or a stipend sufficient to cover the cost of these items. Round-trip air travel will be paid by the home institution.

Each institution may select and nominate one faculty member to visit the partner university as an exchangee. The length of each exchange visit will be approximately one month. Each host institution will determine whether recommended faculty members are acceptable.

Dossiers, including a brief biographical account and a statement of purpose for the exchange period at the host university, must be received six months prior to participation.

Exchangees may be of any branch of learning, but with consideration of the following preferences:

Each host university will provide exchangees with board, lodging, and health insurance, or a stipend sufficient to cover the cost of these items. Round-trip air travel will be paid by the home institution.

The host university will provide study and research privileges equivalent to those available to resident faculty members and graduate students.

The exchangees are expected to study and work according to a mutually agreed upon plan for professional improvement and research. Specific arrangements for special facilities, laboratories, local research, and the like will be agreed upon by the two universities in advance.
