The Sacramento SPCA's first ever Camp Kindness for Grandparents and Grandchildren will feature a fun craft project, opportunities for socializing adoptable animals, games, and much more.

CAMP BASICS

- Each grandparent can bring one or two campers between 4 and 10 years of age.
- Campers should be able to work well with others, and with animals in a group situation.
- We are taking registration on a first-come, first-served basis. All applications must be received no later than June 24, 2013 but we recommend submitting yours as early as possible. ***Camp will probably be full prior to the deadline.*** Your application must be completed in full, and payment must accompany your application.
- We cannot guarantee that the camp session will be equally mixed with gender and race. We will, however, make sure that there is more than one boy or one girl.
- Camp runs from 9:00 a.m. to 12:00 p.m. Transportation is not provided.
- Campers are expected to wear appropriate clothing for animal contact and craft projects.
- Allergies to cats and/or dogs will be impossible to accommodate.
- Opportunities for socialization with SSPCA animals are subject to the availability of appropriate animals.
