

## **Owner Agreement and Release Form**

Note the Appleton/Little Chute TailWaggers Doggy Daycare located at 100 Allegiance Court is independently owned by TR6, Inc and operated by Andrew and Theresa Lauer. This **Owner Agreement and Release Form** is only applicable to the Appleton/Little Chute location.

1. Payments are due at the end of each day for attendance at TailWaggers Doggy Daycare (herein after referred to as TDDC). No shows or cancellations will be charged a penalty of the first day fee unless cancelled 24 hours in advance (excluding holidays where the full amount of the scheduled overnight stay will be charged).

2. Payment may be made by cash, Visa, MasterCard, Discover or debit card. Any discounted packages must be paid in advance and are non-refundable. Punch cards will expire 6 months from date of issuance. Current credit card number and expiration date must be on file at all times and my signature on this agreement authorizes use of the card for payment.

3. I understand that I am solely responsible for any harm or damage caused by my dog(s) while attending TDDC. I further agree to indemnify TDDC, its owner, staff and volunteers for any loss, liability, damage, or costs they may incur due to any harm caused by my dog(s).

4. I agree and understand that any problems that develop with my dog(s) will be treated as deemed best by TDDC, in their sole discretion, and that I assume full responsibility for any and all expenses involved.

5. I agree and understand to indemnify TDDC, its staff, and volunteers for any loss, liability, damage, or cost they may incur due to my dog(s) participation and attendance in the daycare.

6. I agree and understand that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the State of Wisconsin, and if any portion thereof is held invalid, it is agreed and understood that the balance shall continue in full legal force and effect. Should a court determine that any provision waiving liability is deemed unenforceable, TDDC liability shall be limited to the funds paid to it by me for taking care of my dog(s).

7. I agree and understand that in admitting my dog(s), TDDC has relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggression or threatening behavior toward any person or any other dog.

8. TDDC reserves the right to refuse admittance to any dog that does not meet the temperament and health requirements.

9. I authorize TDDC to contact the veterinarian indicated on the Information Form in the event of an emergency to provide appropriate medical treatment to my dog(s) if I am unable to be contacted. I understand that the cost of any such treatment will be my responsibility. I authorize veterinary expenses not to exceed the amount of \$\_\_\_\_\_\_.

10. Daily fees, overnight fees, grooming fees and training fees are as indicated on TDDC services menu and brochure.

11. The policies and fees may be modified by TDDC upon 7 days notice.
