Calculating Cemetery Expenses

Burial

The total cost of the cemetery expenses could include the burial plot, grave liner (the casket is placed into the grave liner to help prevent the grave from collapse), and a marker or monument. You also need to pay interment fees (for the opening and closing of the plot). If cemetery property is already owned, then the funeral provider could include some of these fees in the funeral disbursements, otherwise you may need to complete all the arrangements with the cemetery.

Cremation

The total cost of the cemetery expenses, in addition to the cost of cremation, could include an urn for the cremated remains, and/or a burial plot or niche. You will also need to pay an interment fee (for the opening and closing of the lot, niche or scattering of the cremated remains in a cremation garden)

In Ontario , the majority of cemetery expenses are only subject to GST at 5% up until June 30, 2010. Services prepaid by June 30, 2010 will also be subject to this tax rate.

Beginning July 1, 2010, all cemetery expenses will be subject to HST at 13%.
