

# IMPORTANT 2014 TAX INFORMATION CONCERNING YOUR FORM 1098-T

**REVISED – 12/5/14**

(A) What's new?	What should you do?
<p>We no longer mail form 1098-T. It is available for your viewing and printing on ECC WEB SERVICES.</p> <p><b><i>Your Form 1098-T for calendar year 2014 will be available online for your review and printing starting <u>January 30, 2015</u>. You have until <u>March 16, 2015</u> to update your records - name, Social Security # or Tax Identification # - with the Enrollment Services Department, in order to ensure that a Form 1098-T is issued to you and then submitted to the IRS by the <u>March 31, 2015 deadline</u>.</i></b></p> <p><b><i>Do not wait for the above dates – update your accounts and records now. Please read this entire Notice for more details.</i></b></p>	<p>You can access, view and print the form 1098-T using your current <b>Student ID</b> and <b>PIN</b> as follows:</p> <ul style="list-style-type: none"> <li>• Click onto Internet Explorer</li> <li>• Type “webservices.essex.edu” in the browser address</li> <li>• Click “Enter Secure Area”</li> <li>• Enter Your Student ID and PIN</li> <li>• Click “Student and Financial Aid”</li> <li>• Click “Student Records”</li> <li>• Click “Tax Notification”</li> <li>• Enter Tax Year (i.e. 2014)</li> <li>• Click “Submit”</li> </ul> <p>Be sure to follow the link to page 2 which has “Instructions to Students.”</p> <p><b>&lt;NOTE&gt;</b> Never used Web Services? Your PIN is your date of birth (mm/dd/yy).</p>
(B) Questions...	And answers...
<p>What is a 1098-T?</p>	<p>Form 1098-T is a Tuition Payment Statement that colleges must issue to any student enrolled at the institution and for whom a reportable transaction is made, more specifically for qualified tuition and related expense made.</p>
<p>Why am I unable to access the 1098-T form?</p>	<ul style="list-style-type: none"> <li>• You received financial aid which covered your tuition bill after your payment was made – the refund received returns your out-of-pocket payment to you. OR</li> <li>• You are a visa student who does not have a valid Social Security Number (SSN) or Tax Identification Number (TIN) on file. IRS regulations specify that the College is not required to issue a 1098-T in this situation, unless the student requests the form. OR</li> <li>• You are a student whose SSN or TIN is <b>not</b> on file, or is incorrect in Enrollment Services.</li> </ul>

<p>I reviewed my 1098-T. The SSN or TIN is incorrect. My name is incorrect. What should I do?</p>	<p>Reporting to the IRS depends primarily on your SSN or TIN so it is important to have the correct information on file with the College. Your correct name is also a key element for reporting tax information.</p> <p>Follow these steps to have a corrected 1098-T: <b>Please make corrections before or by March 16<sup>th</sup> 2015.</b></p> <p>Bring your original Social Security card/s or TIN letter to Enrollment Services to correct your student record. If there is a complete SSN change you must present both cards. For name change provide documentation such as a marriage certificate.</p> <ol style="list-style-type: none"> <li>1. After your records are updated in Enrollment Services, contact Ms. Maria Garcia at (973) 877-3021 to have our tax records updated.</li> <li>2. After our tax information is updated you will be able to view and print your Form 1098-T on web services at <a href="http://www.essex.edu">www.essex.edu</a>.</li> </ol>
<p>Is a copy of this form sent to the IRS?</p>	<p><b>Yes.</b> Sec 6050S of the Internal Revenue Code requires institutions to file information returns with the IRS.</p> <p>For tax year 2014 the College is required to file form 1098-T with the IRS by <b>March 31<sup>st</sup>, 2015.</b></p>
<p>What am I supposed to do with the 1098-T form?</p>	<p>Keep it for your records. If you or your parents are required to file an income tax return for <b>2014</b>, the information contained in the 1098-T will help you to determine if you or your parents may claim an education tax credit or deduction.</p>
<p>Can I get a copy of prior years' 1098-T?</p>	<p>Yes, if a 1098-T form was previously generated for you.
