2016 NORTH CENTRAL ARKANSAS BEAUTY PAGEANTS

ALL CONTESTANTS MUST BE A RESIDENT OF ONE OF THE NORTH CENTRAL ARKANSAS DISTRICT FAIR COUNTIES AND BE ATTENDING SCHOOL IN THAT COUNTY IF SCHOOL AGE. A CONTESTANT MUST HAVE BEEN BORN A FEMALE FOR FEMALE PAGEANTS AND MALE FOR MALE PAGEANTS AND A LEGAL RESIDENT OF ARKANSAS. CONTESTANTS CANNOT BE OR AT ANY TIME HAVE BEEN MARRIED, PREGNANT, NOR HAVE HAD A CHILD. CONTESTANT MUST NOT HAVE COMMITTED A CRIME OR HAVE CRIMINAL CHARGES PENDING.

THE ENTRY FORMS MUST BE RECEIVED ONE WEEK AFTER EACH COUNTIES FAIR PAGEANT.

CONTESTANT ONLY WILL BE ADMITTED FREE AT THE DOOR ON THE NIGHT OF CONTEST. CONTESTANTS MAY NOT ENTER AN AGE DIVISION THEY HAVE PREVIOUSLY WON. PAST DISTRICT OR ARKANSAS STATE QUEENS ARE NOT ELIGIBLE TO COMPETE AGAIN.

COMPETITION CLOTHING:

SPORTSWEAR - SPORTS ATTIRE REPRESENTING A FAVORITE ATHLETIC-TYPE SPORT SUCH AS BASEBALL, TENNIS, CHEERLEADING, HUNTING, FISHING, GYMNASTICS, DANCE, ETC. PROPS ARE ACCEPTABLE, BUT MUST BE CARRIED. THEY CANNOT BE USED TO DEMONSTRATE A SPORT.

SWIMSUIT - SWIMSUITS SHOULD BE ONE-PIECE AND APPROPRIATE IN TASTE.

EVENING GOWN - EVENING GOWN OF CHOICE. JEWELRY AND ACCESSORIES SHOULD BE TASTEFUL AND COMPLIMENT THE GOWN. HIGH-HEELED SHOES ARE RECOMMENDED, BUT NOT REQUIRED.

INTERVIEW - DRESS OR SUIT, JEWELRY AND SHOES OF CHOICE - NO HATS, GLOVES, OR PURSES.
