**Presentation:** All accepted two-dimensional works must be appropriately framed and ready to hang. The museum prefers that works on paper be framed under Plexiglas™. All three-dimensional works must be suitably prepared for installation.

**Sales:** Works will not be sold until they reach the artist's reserve price. Once an object reaches the artist's reserve price, the work will be sold to the highest bidder and proceeds split with the artist as indicated above.

**Retail Value / Reserve Price:** Retail value is the amount the artist would like their piece to sell for. Reserve Price is the lowest amount the artist will accept for their piece.

**Shipping:** Shipping to the museum is the responsibility of the artist. In the event a work does not sell, the Square will cover the cost of return shipping. All accepted works must be delivered to the museum no later than 5pm, Wednesday, February 15, 2017.

The Paris Gibson Square Museum of Art announces an open call for artist submissions for our annual art auction. The auction is a premiere social event in north central Montana connecting art collectors with the region's finest artists, set against the backdrop of lively music, good food and drink. The 20th Annual Art Auction will take place in Great Falls, Montana, Saturday, **April 8, 2017**. Proceeds from the event support the museum's exhibitions and related educational programs.

Submission application is due Friday, December 16, 2016, by 5pm. When submitting, please indicate either a 50/50 artist split or a full donation on the submission form. Juried artists who choose a full donation will receive one complimentary ticket to the event and may purchase an additional ticket at cost. All other juried artists may purchase two tickets at cost. The Square reserves the right to place art work in either the live or silent auction. Selected artists for this year's auction and exhibition will be sent an auction contract, which must be signed and returned to the museum with the artwork no later than 5pm on Wednesday, February 15, 2017.

To complement the 20th Annual Art Auction, an exhibition of all art auction selections will be presented in three of the Square's main floor exhibition galleries. Exhibition dates are March 6—April 8, 2017. Artists 18 and younger must have parental consent to participate in the auction. Please feel free to pass along submission information to other artists.

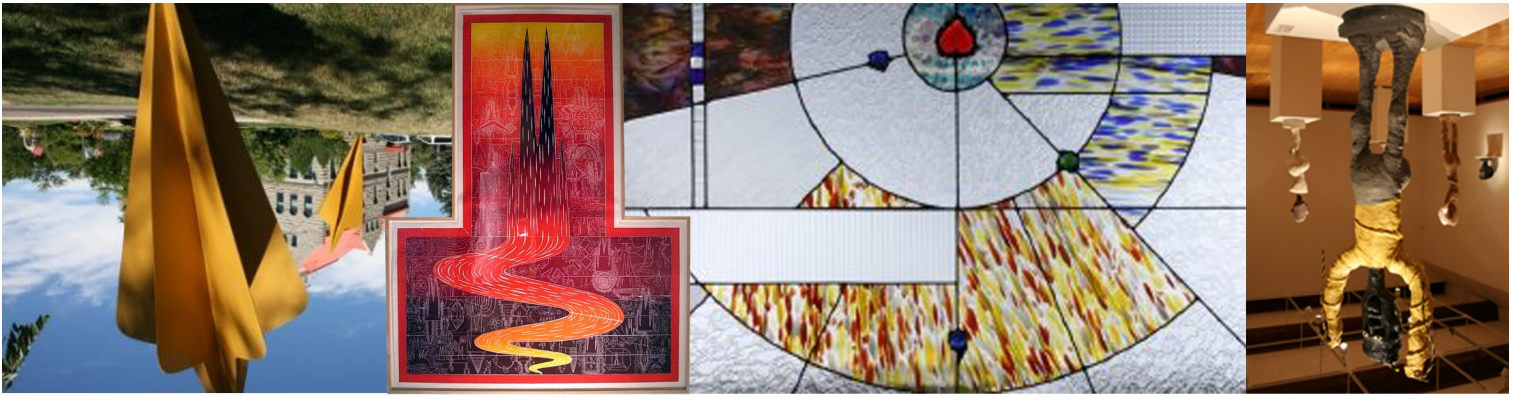
