With your Hunting Package, you will find many of the forms that are necessary and/or helpful to assist you in the legal and other aspects of hunting activities.

Included in your package are the following forms:

1. A Conveyance of Hunting Rights
2. A Simple Lease for Hunting and Fishing
3. A Sample Letter Regarding Hunting Authorization and Agreement
4. A Waiver and Release from Liability for Adult Hunting Land
5. A Waiver and Release from Liability for Minor Hunting Land
6. A Hunting Release by Hunter to Land Owner

II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Hunting Package are found below.

Conveyance of Hunting Rights - This multi-state form is used by an owner to convey the right to hunt on specified land to an individual or a group in return for certain consideration in the form of compensation.

Simple Lease for Hunting and Fishing - This multi-state form is used as a lease of certain lands owned by a lessor to a lessee for hunting and fishing purposes for certain consideration in the form of compensation.

Sample Letter Regarding Hunting Authorization and Agreement - This multi-state form is used as a letter providing authorization and agreement between parties regarding the right to hunt on certain property.

Waiver and Release from Liability for Adult Hunting Land - This multi-state form allows an adult to release an owner of hunting land from liability for injuries which may be incurred while on the premises, taking part in activities.

Waiver and Release from Liability for Minor Hunting Land- This multi-state form allows a parent or guardian to release an owner of hunting land from liability for injuries which may be incurred by a minor child while on the premises, taking part in activities.

Hunting Release by Hunter to Land Owner- This state-specific form is a release from liability given by a hunter to a landowner in exchange for the right to hunt on rural land.
