With your Power of Attorney package, you will find the state specific forms that will help you prepare for and protect yourself and your loved ones from events that may affect your health, finances and personal affairs.

Included in your package are the following forms:

- 1. General Durable Power of Attorney for Property and Finances Effective Upon Disability
- 2. General Durable Power of Attorney for Property and Finances Effective Immediately
- 3. Power of Attorney for Care and Custody of Children
- 4. Health Care Declarations – Living Will

### **II. DESCRIPTIONS OF FORMS**

Brief descriptions of the forms contained in your U.S. Legal Forms™ Power of Attorney Package are found below.

General Durable Power of Attorney for Property and Finances Effective Upon Disability – This General Durable Power of Attorney for Property and Finances Effective upon Disability form is a general, durable power of attorney which is effective ONLY upon the principal's disability, incompetency or incapacity. This form allows you to appoint an attorney-in-fact (agent) to make

decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services.

General Durable Power of Attorney for Property and Finances Effective Immediately - This General Durable Power of Attorney is a general, durable power of attorney which is effective IMMEDIATELY. This form allows you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services. This form complies with all applicable state statutory laws.

Power of Attorney for Care and Custody of Children – This Power of Attorney is a form which provides for the appointment of an attorney-in-fact for the care of a child or children, including health care. This Power of Attorney form requires that the signature of the person giving another the power of attorney to be notarized.

Health Care Declarations - Living Will - Statutory – These forms allow a physician to make medical decisions for a patient when either he/she becomes unconscious and/or terminally ill, and cannot make decisions regarding their medical care.
