II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your Relative Caregiver Legal Documents Package are found below.

Placement of Children With Relatives - This publication summarizes state laws and statutes regarding placement of children with relatives when they are removed from their home and enter foster care. In order for states to receive federal payments for foster care and adoption assistance, federal law requires that they "consider giving preference to an adult relative over a nonrelated caregiver when determining placement for a child, provided that the relative caregiver meets all relevant state child protection standards." Most states give preference or priority to relative placements in their statutes. This publication discusses definitions of "relative," financial support for relative placement, and adoption by relatives.

<u>The Rights of Presumed (Putative) Fathers</u> – This informational guide discusses the rights of the alleged fathers of children born out-of-wedlock and whether states have registries for such fathers.

<u>Disclosure of Confidential Child Abuse and Neglect Records</u> – This guide contains summaries of statutes detailing the officials who may have access to confidential records and the circumstances under which information may be disclosed.

<u>Grounds for Involuntary Termination of Parental Rights</u> – This publication reviews state laws that detail the specific circumstances that must be present when a court terminates the legal parent-child relationship.

<u>California Caregiver's Authorization Affidavit</u>- This form provides for the appointment of an agent for the care of a child or children, including health care.

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
