### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable.

Statutory Advance Healthcare Directive - This Statutory Advance Directive for Healthcare allows you to choose someone to make health care decisions for you when you cannot (or do not want to) make health care decisions for yourself and for you after your death with respect to an autopsy, organ donation, body donation, and final disposition of your body. You can also use this form to state your treatment preferences if you have a terminal condition or if you are in a state of permanent unconsciousness, and to nominate a person to be your guardian should one ever be needed.

<u>Statutory General Power of Attorney</u> – This is a statutory form provided for in the Georgia Code that allows you to name one or more persons to help you handle your financial affairs. It grants your attorney in fact (your agent) VERY broad powers with regard to your property and finances. This Power of Attorney does NOT provide for health care services. As long as you are living, the financial power of attorney will remain in effect even if you become incapacitated or unable to communicate your wishes unless a guardian is appointed for your property or you include a date or specific occurrence when you want your document to be canceled.

<u>New Resident Guide</u> - This is an informational form that details for new residents the various state requirements for residency, voter registration, identification cards, driver's licenses, and vehicle title and registration.

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
