I. FORM LIST

II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms[™] Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable. This form complies with all applicable Georgia laws.

<u>Statutory General Power of Attorney with Durable Provisions - Financial</u> - This is a statutory form provided for in the Georgia Code that allows you to name one or more persons to help you handle your financial affairs. It grants your attorney in fact (your agent) VERY broad powers with regard to your property and finances. This Power of Attorney does NOT provide for health care services. As long as you are living, the financial power of attorney will remain in effect even if you become incapacitated or unable to communicate your wishes unless a guardian is appointed for your property or you include a date or specific occurrence when you want your document to be canceled.

<u>Statutory Advance Directive for Healthcare</u>- This Statutory Advance Directive for Healthcare allows you to choose someone to make health care decisions for you when you cannot (or do not want to) make health care decisions for yourself and for you after your death with respect to an autopsy, organ donation, body donation, and final disposition of your body. You can also use this form to state your treatment preferences if you have a terminal condition or if you are in a state of permanent unconsciousness, and to nominate a person to be your guardian should one ever be needed.

<u>Traveler Information Form</u> - This form allows the traveler to keep their important travel information on hand for easy reference, such as passport, itinerary, airline, hotel, car rental, and other information.

<u>Passport Application</u> - This form is used to apply for a new passport, as opposed to renewal of an existing passport.

Passport Renewal Application - This form is used to renew an existing passport.

<u>Travel Expense/Reimbursement Form</u> - This form is used to request a reimbursement of funds used by an employee for business travel.

<u>Babysitter's Emergency Information Form</u> - This form is an important tool to ensure the safety of your children while in the care of a babysitter. Vital contact, medical, and emergency information can be provided to easily reference if needed.

<u>Pet Boarding Agreement</u> - This form is an agreement between a pet owner and a pet boarder that will care for a pet while the owner is traveling away from home.

It is also helpful to be able to see the location of the form fields. Go to the View menu, click on Toolbars, and then select Forms. This will open the Forms toolbar. Look for the button on the Forms toolbar that resembles a shaded letter "a". Click this button and the form fields will be visible.

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
