II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms[™] Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable. This form complies with all applicable Hawaii laws.

<u>Statutory Power of Attorney for Property and Finances</u> - This Statutory Power of Attorney is a general, durable power of attorney that is effective IMMEDIATELY, unless you state otherwise. You can use this form to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, management, banking, business, and other matters for you. The choice of powers you can individually select to grant to an agent in this power of attorney are very broad, but do NOT provide for health care services. This form follows the specific language of state statutory laws.

<u>Advance Health Care Directive</u> - The term "health care directive" refers to documents such as a Living Will and a Durable Healthcare Power of Attorney, which enable you to exercise your legal right to accept or refuse life-sustaining procedures as well as other medical treatments. This form complies with all applicable Hawaii laws.

<u>Traveler Information Form</u> - This form allows the traveler to keep their important travel information on hand for easy reference, such as passport, itinerary, airline, hotel, car rental, and other information.

<u>Passport Application</u> - This form is used to apply for a new passport, as opposed to renewal of an existing passport.

Passport Renewal Application - This form is used to renew an existing passport.

<u>Travel Expense/Reimbursement Form</u> - This form is used to request a reimbursement of funds used by an employee for business travel.

<u>Babysitter's Emergency Information Form</u> - This form is an important tool to ensure the safety of your children while in the care of a babysitter. Vital contact, medical, and emergency information can be provided to easily reference if needed.

<u>Pet Boarding Agreement</u> - This form is an agreement between a pet owner and a pet boarder that will care for a pet while the owner is traveling away from home.

It is also helpful to be able to see the location of the form fields. Go to the View menu, click on Toolbars, and then select Forms. This will open the Forms toolbar. Look for the button on the Forms toolbar that resembles a shaded letter "a". Click this button and the form fields will be visible.

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
