II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms[™] Amendment to Lease package are found below.

<u>Amendment of Residential Lease</u> - This Amendment of Residential Lease permits changes to a lease agreement that will be incorporated as part of the overall lease contract. The structure of this form complies with applicable state statutes.

<u>Model Lease Amendment for Short Term Rent Deferral</u> - This form is a model lease amendment providing rent deferral for financially strapped tenants. It also contains provisions for the payment of any deferred rent.

<u>Letter Regarding An Amendment to Tenants Lease</u> - This letter is sent to the tenant 60 days prior to lease expiration. It explains the effective date of lease amendment and response deadline.

<u>Lease Clause to Keep Responsible After Assigned Lease is Modified</u> - This form is a lease clause that keeps the tenant liable for responsibilities in the lease after it has been modified.
