II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms $^{\text{TM}}$ Power of Attorney Package are found below.

<u>Statutory General Power of Attorney</u> – This Power of Attorney is a statutory form which means it has been approved by the state legislature. It provides for the appointment of an attorney-in-fact for various matters, which you select, including property, finances, real estate, business, banking, litigation and many more options. Note: Do not alter this statutory form other than to include the optional provisions listed. Only complete it as desired.

<u>Power of Attorney for Care and Custody of Children</u> – This Power of Attorney is a form which provides for the appointment of an attorney-in-fact for the care of a child or children, including health care. This Power of Attorney form requires that the signature of the person giving another the power of attorney to be notarized.

<u>Statutory Durable Power of Attorney for Health Care</u> – This Power of Attorney for Health Care allows you to appoint a person to make health care decisions for you when you are not capable of making the decision. You may limit this person's authority or the duration of his/her authority to speak for you.
