- Landlord Consent to Assignment of Lease

II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Assignment of Lease Package are found below.

Assignment of Lease from Lessor with Notice of Assignment - This state-specific form is an assignment from an original landlord (lessor) to a new lessor of his or her rights in a rental property during the term of the lease assigned. This form also contains notice to the lessee or tenant of the assignment and a new address to which future rental payments should be sent.

Landlord Consent to Assignment of Lease - This multi-state form is used by a landlord to consent to a tenant assigning his or her leasehold interest in a lease agreement to a new tenant.
